**RESOLUTION OF THE BOARD OF EDUCATION OF THE SAN JOSÉ UNIFIED  
SCHOOL DISTRICT OF THE COUNTY OF SANTA CLARA, STATE OF  
CALIFORNIA, DECLARING RESULT OF THE MEASURE A ELECTION HELD ON  
MAY 6, 2025**

**RESOLVED** by the Board of Education (“Board”) of the San José Unified School District (“District”), a school district of the County of Santa Clara, State of California, that:

**WHEREAS**, on January 16, 2025, the Board approved and adopted Resolution 2025-01-16-02, ordering a special mailed ballot election within the boundaries of the District to be held on May 6, 2025 (the “Election”), and establishing the specifications for and conduct of the Election; and

**WHEREAS**, the measure presented to the voters contained the question of whether the District should impose a qualified special tax for the educational purposes stated in the ballot measure (“Measure A”); and

**WHEREAS**, the County of Santa Clara conducted the Election on May 6, 2025 by mail ballot; and

**WHEREAS**, the County of Santa Clara Registrar of Voters (the “Registrar of Voters”) canvassed and certified the results of the election on June 5, 2025; and

**WHEREAS**, the approval of two-thirds of the electorate was required to levy the qualified special tax described in Measure A, pursuant to California Constitution, Article XIII A, section 4 and Government Code sections 50075 et seq.; and

**WHEREAS**, the “Yes” votes cast in favor of Measure A did not meet or exceed the required two-thirds threshold for approval of the measure and levy of the qualified special tax; and

**WHEREAS**, pursuant to Elections Code section 15400, the District shall declare the results of each election under the District’s jurisdiction and each measure voted on at each election.

**NOW, THEREFORE, IT IS DETERMINED AND ORDERED** as follows:

**Section 1. Recitals.** This Board hereby finds and determines that the foregoing recitals are true and correct.

**Section 2. Official Results of the Election.** The Board accepts and declares the Official Final Results of the Measure A Election as canvassed and certified by the Registrar of Voters on June 5, 2025 (the “Official Results”). The Official Results are as follows: “Yes” votes: 16,295 (60.51%); “No” votes: 10,634 (39.49%).

**Section 3. Declaration of Result of Measure A Election.** The Board finds and declares that Measure A was not approved at the May 6, 2025 Election.
