RESOLUTION ON FULL RETURN FOR THE 2021-2022 SCHOOL YEAR

**A RESOLUTION TO DECLARE THAT THE NOVATO UNIFIED SCHOOL
DISTRICT WILL RETURN TO FULL DAY BELL SCHEDULES
FOR THE 2021-22 SCHOOL YEAR**

WHEREAS, on March 13, 2020, the Novato Unified School District transitioned to distance learning as a result of the COVID-19 pandemic and shelter-in-place orders from the County of Marin Public Health; and

WHEREAS, on July 28, 2020, the Board of Trustees for the Novato Unified School District approved the Reentry Plan for the 2020-2021 school year; and

WHEREAS, on August 20, 2020, the County of Marin was in the Purple Tier as defined in the California Department of Health Blueprint for a Safer Economy and under a Regional Stay at Home Order; and

WHEREAS, on October 6, 2020, the Board of Trustees for the Novato Unified School District approved the Updated Reentry Plan for the 2020-2021 school year ; and

WHEREAS, on October 26, 2020, Elementary Special Day Classes, Transitional Kindergarten, and Kindergarten return to hybrid learning; and

WHEREAS, on November 9, 2020, Grades 1 and 2 return to hybrid learning; and

WHEREAS, on November 30, 2020, Grades 3,4,5 and 6 return to hybrid learning; and

WHEREAS, on January 4, 2021, the County of Marin was in the Purple Tier and as per the Updated Reentry Plan approved on October 6, 2020, the Reentry Plan was paused; and

WHEREAS, on January 4, 2021, the County of Marin exited the Purple Tier; and

WHEREAS, on February 9, 2021, the Board of Trustees for the Novato Unified School District approved the revised return to flexible in-person learning plan; and

WHEREAS, on February 22, 2021, Grades 7 and 8 return to hybrid learning; and

WHEREAS, on March 1, 2021, Grades 9 and 10 return to hybrid learning; and

WHEREAS, on March 8, 2021, Grades 11 and 12 return to hybrid learning; and

WHEREAS, on March 16, 2021, the Board of Trustees for the Novato Unified School District approved the modified full return of students on April 12, 2021 ; and

WHEREAS, on April 12, 2021, Grades TK-12 returned to NUSD campuses in a modified full return schedule; and

WHEREAS, COVID-19 vaccines began to be distributed in January 2021; and

WHEREAS, as of May 21, 2021, the County of Marin has had 2,471,573 “student days” and 12 suspected in-school transmissions: and

WHEREAS, on May 14, 2021, Governor Newsom’s May Revision for the California K-12 Education Budget assumes a return to full-time instruction for the 2021-22 school year.

NOW, THEREFORE, BE IT RESOLVED that the Novato Unified School District Board of Trustees hereby declares that the Novato Unified School District will return to full day bell schedules, similar to the bell schedules at the start of the 2019-2020 school year, for the 2021-2022 school year.
