Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. Students learn about citizenship beginning in first grade, and in second grade, students explore the lives of both current and historical figures. The theme in third grade is continuity and change, with California the subject of student studies in fourth grade. #### 2025-26 Opportunities for Parental Involvement

Lincoln has an active parent community, the “Parent Faculty Organization” (PFO), a non-profit organization supporting student activities. The PFO organizes fundraising events to provide student enrichment activities such as special assemblies and prizes for the weekly “Lincoln Leopards Student Store”. Parents also serve on the English Learner Advisory Committee (ELAC) and the School Site Council (SSC). ## 2025-26 School Safety Plan

The 2024-2025 School Safety Comprehensive Framework by Santa Rosa City Schools emphasizes creating a safe, inclusive, and empowering environment that supports both academic success and emotional well-being. Grounded in the values of embrace, engage, and empower, the framework outlines nine focus areas: campus security enhancements like controlled access and surveillance, sufficient safety equipment, and professional development for staff regarding safety protocols and wellness. It also highlights mental health supports such as counseling services and conflict resolution programs, and collaboration with first responders and community partners for coordinated incident responses. A multidisciplinary threat assessment protocol, standardized emergency responses, and the implementation of an Incident Command System (ICS) ensure the district is prepared for various emergencies. Finally, reunification and recovery protocols aim to restore normalcy post-crisis, focusing on emotional and logistical support for students and families.

The plan also integrates continuous improvement measures, such as regularly updating emergency plans and conducting drills, and is aligned with the district's Facilities Master Plan to ensure feasibility and sustainability. The framework underscores the collective responsibility of staff, families, students, and community partners in fostering a culture of safety and readiness. By addressing physical, emotional, and systemic aspects of school safety, the framework sets the foundation for nurturing an environment where students feel secure and empowered to achieve their full potential. It reaffirms the district's commitment to collaborative, data-driven approaches to enhance safety across all campuses.

## Fiscal Year 2024-25 Types of Services Funded

In 2014-15 two new positions were funded with LCAP money, the Student Engagement Worker and Family Engagement Facilitator. The Student Engagement Worker runs after school clubs, organized recess activities and participates in planning monthly events for students. The Family Engagement Facilitator assists families with translation, paperwork and attends parent meetings such as PFO, ELAC, SSC and SSTs. A full-time counselor works with a part-time clinician to provide counseling services for students and families. Additional services provided by the district include a speech and language teacher who is on site 5 days a week, an Occupational Therapist 4 days a week, an Adaptive Physical Educator two days a weeks, two school psychologists on site each two days per week, a nurse on site a total one day per week, and a hearing and vision specialist who is available as needed.

### Special Education Program

A resource specialist works with special education students who have Individualized Education Programs (IEP'S) and are in regular classrooms. We have two Special Day Classes (SDC) for educationally and emotionally challenged students ranging from mild to moderate disabilities and six classes for the moderate to severe students in the Extensive Support Needs (ESN)

program. Each of the SDC classes has two full-time instructional assistants, while the ESN classes have three to four instructional assistants. Identified students also receive adaptive physical education. Teachers receive assistance and direction from an occupational therapist. If a child requires them, teachers may also receive county services such as vision and hearing screenings. Individual assistants are provided for our full inclusion students.

### English Learner Program

All students, not fluent in English, receive ELD instruction according to their English Language Proficiency Assessments For California (ELPAC) levels for a minimum of thirty minutes five days a week, in addition to ELD instruction for the whole classroom. Primary students receive extra support with the Early Reading Intervention (ERI) curriculum. Abraham Lincoln's Intervention Team provides small group instruction throughout the day supporting K-6th students in the Walk to Read program.

Intervention Support at Abraham Lincoln School has two full time Instructional Assistants to support the intervention Walk to Read program five days a week K-6th. Additionally, after-school tutoring is offered for low-performing students.

## Professional Development

The LEA provides various professional development opportunities for staff:

**Grade-Level Collaboration:** Grade-level teams meet twice a year to align instructional practices.

**Monthly Curriculum Support:** Teachers receive monthly guidance on curriculum implementation and strategies for effective first instruction.

**Math Training:** Staff participated in two additional math sessions emphasizing engaging practices from the new math framework.

**Support for Multilingual Learners:** Collaborative opportunities to address multilingual learners' needs are offered multiple times annually.

### Specialized Programs:

Transitional Kindergarten and Kindergarten teachers engaged in the Pyramid Model project to address challenging behaviors and build young children's social skills.

Expanded Learning Opportunity programs provided training for site leaders, after-school professionals, and summer teams, covering inclusive practices, de-escalation strategies, registration support, best practices, and team building.

## Professional Development

### District-Wide Professional Development:

Two annual professional development days are provided for certificated and classified staff. This year's focus included school safety through Essential 5 and reviewing Comprehensive School Safety Plans.

Ethnic Studies training is offered at three levels: Ethnic Studies 1.0, 2.0, and 3.0.

Elementary administrators meet bi-monthly to align Tier 1 practices using district-adopted curriculum.

### Math Redesign:

Professional learning focused on district-wide coherence from elementary through 12th grade, emphasizing culturally relevant math modeling, formative assessments, Building Thinking Classrooms, and Boaler's strategies for fostering a growth mindset and positive math identity.

Training supported the implementation of the New California Math Framework at school sites and for leadership teams.
