

**Policy 5125.1: Release Of Directory Information**

The Governing Board recognizes the importance of maintaining the confidentiality of directory information and therefore authorizes the release of such information, only including to news media or nonprofit organizations, in accordance with law, Board policy, and administrative regulation.

~~The Superintendent or designee may release student directory information to representatives of the news media or nonprofit organizations in accordance with Board policy and administrative regulation.~~

The Superintendent or designee may limit or deny the release of specific categories of directory information to any public or private nonprofit organization based on the determination of the best interests of district students. (Education Code 49073)

A student's directory information shall only be included in the minutes of the Board's meeting in accordance with Board Bylaw 9324 - Minutes and Recordings.

~~Colleges and prospective employers, including military recruiters, shall have access to directory information. Military recruiters shall have access to a student's name, address, and telephone number, unless the student's parent/guardian, or the student, if the student is 18 years of age or older, has requested specified that the such information not be released in accordance with law and administrative regulation. (20 USC 7908; 10 USC 503; Education Code 49603)~~

Under no circumstances shall directory information be disclosed to a private profit-making entity, except for representatives of the news media and prospective employers, including prospective employers, in accordance with law, Board policy, and administrative regulation. Private schools and colleges may be given the names and addresses of 12th grade students and students who are no longer enrolled provided they use this information only for the purposes directly related to the institution's academic or professional goals. (Education Code 49073)
