

CHRONOLOGY OF THE AGENDA ITEM RFP 25-603 (Nursing Services for Students with Disabilities)

- Extension – continuation; extend the period of time

Vacancies of appropriately trained nurses have increased over the last few years. No single company has been able to provide a sufficient number of nurses to cover DeKalb’s needs. DCSD has been unable to fill all vacancies when employees resign or retire. Currently, there are 24 special education nurses that are district employees. The District is currently contracting with fifteen (15) nurses for special education and two (1) nurse, to support students with significant medical needs who are eligible for Section 504 services. The cost incurred by these vendors, due to the hourly rate and number of nurses needed has exceeded \$100,000 based upon data shared below over multiple school years.

The chart below provides a historical perspective of the nursing expenses in the District:
