Section A: Updates to Breaded Products

Yang's has made minor changes to the formulation of breaded products. **Please note that the ingredients, pack sizes, serving sizes, and Child Nutrition crediting of these products remain unchanged; the only change is a slight decrease in the donated food pounds per case (chicken legs chilled USDA code 100113).** Attached is our SY25-26 SEPDS reflecting these changes. The changes in donated food pounds per case are summarized as follows:
