## **Executive Summary**

G. S. §115C-12(25) requires the State Board of Education to submit a report to the Joint Legislative Education Oversight Committee (JLEOC) annually regarding districts and schools identified as low-performing, effective improvement planning, and recommendations for additional legislation to improve student performance and increase local flexibility.

This report contains information regarding the implementation of new and/or amended statute in G. S. §115C-105.37. Identification of low-performing schools; G. S. §115C-105.37B. Reform of continually low performing schools; and G. S. §115C-105.39A. Identification of low-performing local school administrative units. Specifically, the report provides a summary about the results of the steps and process developed and implemented by the North Carolina Department of Public Instruction to support those districts and schools identified as low performing from the 2018-19 results, and a summary of the 2019-20 accountability results for low-performing districts and schools around the School Performance Grades and EVAAS Growth status. Additionally, the report includes the plans for reviewing and providing feedback on the improvement plans based on the 2019-20 results and appendices with the resources, documents, and calendar of events to be provided to districts and schools across the state with low-performing schools.

The United States Department of Education (USED) and the North Carolina General Assembly granted the North Carolina Department of Public Instruction a waiver from administering the statewide assessments required by federal law and from School Performance Grade reporting. Based on the waiver from the USED and North Carolina General Assembly school designations from the 2019–20 school year, must remain in effect; therefore, the annual identification of low-performing schools, low-performing districts, Comprehensive Support and Improvement schools and Targeted Support and Improvement schools was not applied, and these lists remain the same for the 2020–2021 school year.

## Overview of Legislation and District/School Data

The following report provides a brief summary of legislation about the definition of low-performing schools and low-performing local school administrative units. In addition, the report provides a general analysis of trends and patterns identified in the plans submitted to the Department of Public Instruction for feedback. Also included in the report are the final results of performance and growth data for low-performing districts and schools for the 2019-20 school year based on the analysis of School Performance Grades (SPG) and EVAAS Growth data according to the End of Grade (EOG) and End of Course (EOC) assessments, which are aligned to the North Carolina Standard Course of Study in English Language Arts/Reading and Mathematics and the Essential Standards in Science, for all public schools and public charter schools. The report specifically presents the following information and data:

1. Summary of the legislation concerning low-performing districts and schools,
2. Summary of findings based on the submitted Low-Performing Local School Administrative Units' and Schools' improvement plans,
3. Summary analysis of the 2019-20 Accountability results, and
4. Overview of the projected timeline and process for the improvement plans based on the 2019-20 low-performing results.

### Legislation

In September 2015, Session Law 2015-241 House Bill 97, provided amended definitions for low-performing schools and a new designation for low-performing districts. Included in both the amended and new designations were specifically defined processes, procedures, and requirements for low-performing schools and districts. The following tables provide summary information regarding the requirements based on current legislation:

### *Trends and Patterns from Low-Performing Plans*

As part of the Regional Support Structure within District and Regional Support, Regional Case Managers provided feedback to Low-Performing districts, schools, and charters within each region through NCStar. NCStar is a web-based tool that guides a district or school team in charting its improvement and managing the continuous improvement process. Regional Case Managers facilitated trainings on NCStar conducted by Federal Programs and Monitoring. The plans for improvement submitted by low-performing districts and schools contained strategies developed by the improvement teams and were submitted to the North Carolina Department of Public Instruction's Regional Case Managers for feedback through NCStar. Many of the plans contained similar strategies for addressing the needs in low-performing schools and the data summarized in Table 3 also suggests implications for ongoing professional development to continue to build the capacity of district and school personnel. Identifying these trends has been an integral aspect of developing and continuing effective practices of support for classroom, building level, and district level personnel.

In addition to the themes found in Table 3, one common finding is the limited coaching statewide that is occurring from district to schools regarding school improvement. Many districts lack the human capital and resources to devote time to assist school administrators and/or school improvement teams. A recent study by the SERVE Center at UNC-G also found the need for constructive communication between districts and schools around school improvement planning<sup>1</sup>. Respondents in the SERVE study indicated that the support and guidance provided by district coaches when available were of great help. Unfortunately, a number of respondents to the study shared that no district coach was assigned to their school.

**Table 3: Common Themes in Low-Performing Plans**

Identifying and analyzing relevant, high yield data points
Developing goals aligned with identified needs that are <b>Specific, Measurable, Attainable, Relevant, and Time-Bound (SMART)</b>
Integrating evidence-based strategies and action steps
Understanding improvement is a process and the plan is a living document that should change to best meet the needs of students
Identifying those areas for improvement to target rather than trying to address all areas of need- a concentrated approach to school improvement
Continuously revisiting the school’s improvement plan and adjusting as needed for progress
Continuing need for professional development of new teachers/leaders since many of the low-performing schools experience as much as 50% turnover year to year
Approaches that include the community and family engagement and support in improving the schools

As required per statute, all LP districts and schools that submitted plans received feedback from NCDPI. During the 2019-20 year, a high of 97.7% of LP schools submitted a plan. Out of 487 schools, the following LP schools never submitted a plan through NCStar: Appalachian State Academy at Middle Fork (lab school), Carter Community Charter (charter), Charlotte Choice Charter (charter), ECU Community School (lab school), Elizabeth City Middle (ECPCS), Essie Mae Kiser Foxx Charter (charter), Institute for the Development of Young Leaders (charter), Pasquotank High School (ECPCS), Three Rivers School (charter), UpRoar Leadership Academy (charter), and VERITAS Community School (charter).

Since the status for these schools continue with the 2020-2021 academic year, a follow-up process will be implemented to encourage these schools’ compliance with G. S.§115C-105.37.

## Strategic Reform Services: School Reform Models

In addition to the themes identified through these plans, the State Board of Education sought to identify practices that nationally supported school and district improvement. Successful implementation with fidelity of the components of the school reform models Transformation, Turnaround, Restart, and Closure showed promise in improving chronically under-performing schools nationally. Aligning with North Carolina’s law for reform of low-performing schools (G.S. 115C-105.37B) the State Board of Education adopted a policy (DSTR-040) allowing recurring low-performing schools an opportunity to apply for approval to implement components of these reform initiatives.

In March of 2020, the State Board of Education approved updates to the DSTR-040 policy, which provided clarification on the criteria for Academic Gain, the monitoring cycle, and the continued authorization for Restart schools.

Summarized information about each reform initiative can be found in Table 4. Recurring low-performing schools are those schools that have been low-performing for two of the previous three consecutive years. The list of recurring low-performing schools for 2019-20 can be found in the Appendix.

**Table 4: School Reform Models**

<b>Transformation</b>	In order to qualify for implementation of the transformation model, the LEA must demonstrate that a school has created a plan for developing and improving teacher and school leader effectiveness; for implementing comprehensive instructional reform strategies; for increasing learning time; for creating community-oriented schools; and for providing operational flexibility and sustain support. The LEA shall submit specific goals for academic achievement and shall submit a budget showing the revenues and expenditures needed to reach the goals.
<b>Turnaround</b>	In order to qualify for implementation of the turnaround model, the LEA submits specific grounds supporting the implementation of this model; specifies the academic goals expected from implementation of this model; specifies the procedures to be utilized in removing staff, including procedures consistent with Due Process; describes with specificity the new governance structure and the budget to be implemented; sets forth specific academic achievement expected to be realized from use of this model.

<b>Restart</b>	In order to qualify for implementation of the restart model, the LEA submits a detailed plan outlining the goals to be achieved, including how to provide each student with the opportunity for a sound basic education; a statement as to how operating the school with the same exemptions from statutes and rules as a charter school authorized under N.C.G.S. 115C-218 et seq. will facilitate accomplishing these goals; how these exemptions will increase student achievement; whether the LEA will employ an educational management organization and, if so, the name and credentials of that organization and a budget setting out anticipated revenue and expenditures necessary to achieve the goal. A school operated under this subdivision remains under the control of the local board of education, and employees assigned to the school are employees of the local school administrative unit.
<b>Closure</b>	In order to qualify for implementation of the closure model, the LEA submits the specific grounds recommending closure of a particular school; the procedures it intends to follow in closing the school, including opportunities for public hearing; the procedures for ensuring a smooth transition for employee and students affected by the closure; how the resources realized from closure will continue to support student achievement, and the specific academic gains expected to be realized by the closure.

Thirty-two school districts have submitted applications and have been approved to implement a reform model, all of which selected the Restart Model. Table 4.1 summarizes the current information of authorization for reform model implementation.

All Reform Models are required by GS 115C-105.37B and State Board Policy DSTR-040 to submit an Annual Report documenting academic gains. Schools complete the report all subsequent years after completing the first year of implementation of the approved Reform Model. Table 4.2 summarizes the number of schools submitting an annual report after their initial year of implementation. The 58 schools in Cohort 1 have implemented since 2016-2017 or 2017-2018 and 49 schools from Cohort 2 who have implemented since 2018-2019.

Restart Model schools are monitored for their progress in demonstrating Academic Gain. Five components make up the criteria for Academic Gain including: Recurring Low-Performing designation, School Growth Status, Achievement Score, Subgroup Growth Status, and school defined Flexibility Outcomes.

Yearly progress monitoring is communicated informing the school if they are above, meeting, or not meeting the expectations for Academic Gain and based on a comparison between the year before implementation and the most recent year of implementation. The descriptions of expectations are included below, and Table 4.3 provides a summary of the schools’ Academic Gain progress.

- *Above Expectations* – No Longer Recurring Low Performing + Meeting or Exceeding School Growth Status
- *Meeting Expectations* – Demonstrating Academic Gain through a combination of the components
- *Not Meeting Expectations* – Declining in Achievement Score and School Growth Status

The twenty-one schools not yet on track to meet Academic Gain expectations are being offered support through the Strategic Reform level of support within District and Regional Support. The support focuses on assistance with school improvement planning and professional development in planning with Restart flexibilities.

Of the 107 schools implementing the Restart Model, Table 4.4 represents a summary of the Academic Gain components within the 107 schools that submitted the December 2019 Restart Annual Report. The Flexibilities Outcomes are self-reported by the schools in the annual report. The 107 schools include 58 schools from Cohort 1 who have implemented since 2016-2017 or 2017-2018 and 49 schools from Cohort 2 who have implemented since 2018-2019.

## Low-Performing Districts and Schools

In September of 2019 the State Board of Education approved the lists of low-performing schools, traditional and charter, and low-performing districts and recurring low-performing schools. The full list of schools and districts can be found in the Appendix beginning on **page 20**. The table below provides a summary of the low-performing schools and districts by NC State Board Region. Due to COVID19 and the federal waiver to allow no testing in the Spring of 2020, the list of Low-Performing Schools remains the same and is based on the 2018-2019 performance data.

When comparing the results from 2017-18 to 2018-19, there is an overall increase of 8 low-performing schools, from 479 to 487. The same is true when comparing the low-performing districts in 2017-18 to 2018-19, with an increase of 1 low-performing district, from 8 to 9. Further analysis of the data shows a breakdown of schools and districts that remain on the list, the totals that are no longer low-performing and those schools and districts newly identified in the recent release of Accountability results. Table 6 provides the summary of schools and districts removed, newly identified, the net change and new total from the 2018-19 data.

## Overview of North Carolina Department of Public Instruction Support

The Department of Public Instruction provides a series of support services to guide districts and schools through the requirements. Upon the State Board of Education’s final approval of the low-performing local administrative units’ and low-performing schools’ lists, communication was shared with all superintendents and charter school directors regarding next steps. In the month of September 2019, the Department’s District and Regional Support unit provided multiple opportunities to attend a webinar explaining the requirements of the law and the processes and procedures in place to support districts and schools through the requirements. At the same time District and Regional Support, in collaboration with Department of Public Instruction’s Federal Programs and Monitoring Division will provide training to schools and districts on the NCStar tool which all low-performing districts and schools will utilize to develop and monitor implementation of their district/school improvement plan.

Table 8 below lists the support and corresponding resources provided to all districts and schools. Included in the Appendix are samples of each of the resources listed.

### *District and Regional Support*

District & Regional Support (DRS) develops and aligns systems, processes, and procedures to provide a unified system of support to North Carolina Public School Units (PSUs) that result in every child having equitable access to a meaningful, sound basic education through:

- A regional structure coordinating academic supports statewide
- Opportunities for educator recognition, advancement, and growth
- Diagnostic services that identify areas of improvements for schools and districts
- Strategic reform strategies that lead to innovation and student success
- Effective partnerships to intervene on critical areas of need

These services are divided into four levels of support for schools: Statewide, Diagnostic, Strategic Reform, and Intensive Intervention. As schools needs increase so does the level of services provided. Diagnostic Services provide evidence-based frameworks to assist targeted districts/schools in analyzing and determining the impact of practices on student learning and diagnosing strengths and weaknesses to support improved outcomes. These steps are essential in supporting struggling schools. A description of those services is below:

### *Diagnostic Services: Comprehensive Needs Assessments and Follow-Up Support*

NC DPI's Comprehensive Needs Assessment process is a systematic assessment of instructional practices, processes, and systems within a school district that assists district and school leadership in determining needs, examining their nature and causes, and setting priorities for future action led by the Instructional Review Coach (IRC) team. The assessment consequently guides meaningful strategic/improvement planning at both the district or school level and suggests benchmarks to guide improvement evaluation. Research suggests that school districts that undergo a careful analysis of data and information make better decisions about what to change and how to institutionalize systemic change. The district/school Comprehensive Needs Assessment provides a framework for conducting this analysis in a process-driven, evidence-based way.

Prior to the assessment, professional development is provided to principals and central office staff that explains the following:

- the Comprehensive Needs Assessment process;
- the NC DPI Comprehensive Needs Assessment rubric utilized during the district/school assessment;
- personnel's role in the assessment; and
- preparation of a Self-Evaluation that begins the review process.

The site visit conducted as part of the process consists of the following:

- collaborative discussions with district and school leadership;
- classroom visits; and
- focus group sessions with teachers, students, and parents.

All of which are underpinned by the NC DPI Comprehensive Needs Assessment rubric.

The District Comprehensive Needs Assessment site visit consists of the following:

- collaborative discussions with the superintendent;
- collaborative discussions with district-level staff;
- focus group sessions with school board members and principals; and
- observation of a school board meeting.

All of which are underpinned by the NC DPI Comprehensive Needs Assessment rubric.

The assessment culminates with a report that

- triangulates the evidence found during the assessment process and reports findings for all six dimensions of the NC DPI Comprehensive Needs Assessment rubric in terms of evidence and resulting impact on students and improvement efforts;
- is written in draft form and sent to district and school leadership for a check of factual accuracy; and

- is finalized and provided to district, school, and Department of Public Instruction leaders so that they may use this information to drive, revise, and support improvement efforts.

After the completion of the Comprehensive Needs Assessment Process, the Instructional Review Coach team provides follow-up support by way of a two-day professional development session referred to as the “CNA Unpacking.” Over the course of those two days an assigned Instructional Review Coach works with the school principal and the School Improvement Team to accomplish the following:

- deepening the staff’s understanding of the NC DPI Comprehensive Needs Assessment process and rubric;
- reading the report in its entirety and identifying and analyzing the evidence reported with a focus on noting and discussing IMPACT on students and improvement efforts;
- engaging in and completing a root cause analysis exercise around one of the identified areas for improvement;
- engaging in a detailed strategic planning activity to address one of the resulting root causes; and
- connecting resulting actions to existing improvement indicators and incorporating changes and revisions based on the work over the course of the two-day session into the school’s improvement plan.

Follow-up support for districts that have engaged in a Comprehensive Needs Assessment includes engaging with the Superintendent, district-level staff, and some board members in the same professional development work as described above to support district leadership in improving the districts strategic plan and support for schools.

In the next year, District and Regional Support is prioritizing identified Low-Performing Districts to receive diagnostic support. This support will include a Comprehensive Needs Assessment and follow-up Unpacking support for each school in each low performing district that culminates in a district level Comprehensive Needs Assessment that provides a district-wide trend analysis. Currently, there are eight identified Low-Performing Districts.

In response to House Bill 1050, the Comprehensive Needs Assessment rubrics will be amended to include a high-level review of early childhood learning opportunities in low-performing administrative units, highlighting any areas for improvement that may arise related to (1) training levels of early childhood teachers and support staff (2) the ratio of students to teachers (3) alignment of preschool curricula to curricula for kindergarten through third grade (4) kindergarten transition supports, including collaboration with preschool educators and (5) kindergarten preparedness within the context of the Comprehensive Needs Assessment process.

### *Regional Support Structure*

The regional support structure organizes services to schools and districts through an efficient geographically based model. The Regional Case Manager (RCM) leads the support and services provided in each region. The RCM facilitates and participates in the design, implementation, and evaluation of all services and school improvement practices for North Carolina districts and schools with a partnership focus on those districts designated as low performing.

## **Recommendations for Additional School Improvement Legislation**

- Fund the Leandro Remedial Plan for fiscal year 2021 section V:
  - Develop the State’s capacity to fully support the improvement of its lowest-performing schools and districts by fully implementing the NC State Board of Education’s regional support model to support the improvement of low-performing and high-poverty schools by providing support in needed content areas and instructional and leadership coaching.
  - Develop the State’s capacity to initiate District & Regional Support’s plan to provide direct, comprehensive, and progressive turnaround assistance to the State’s chronically low-performing schools and low-performing districts.
