Reporting Requirements

S.L. 2020-3, sec. 2.7(e); G.S. 115C-83.10; G.S. 115C-218.85(b)(4)

SECTION 2.7.(e) Reporting Requirements. – For the 2020-2021 school year, the following applies:

- (1) Accountability reporting described in G.S. 115C-83.10 shall not be required based on data from the 2019-2020 school year, except that by September 1, 2020, local boards of education shall report to the State Board the following:
 - a. The number and percentage of first grade students on track and not on track to meet year-end expectations based on assessments completed on or before March 13, 2020.
 - b. The number and percentage of second grade students on track and not on track to meet year-end expectations based on assessments completed on or before March 13, 2020.
 - c. The number and percentage of third grade students on track and not on track to meet year-end expectations based on assessments completed on or before March 13, 2020.
 - d. The number and percentage of third grade students retained pursuant to subsection (a) of this section for reading deficiencies.
- (2) Reporting requirements described in G.S. 115C-218.85(b)(4) shall not be required based on data from the 2019-2020 school year, except that by September 1, 2020, charter schools and other public school units subject to charter school statutory requirements shall report to the State Board the following:
 - a. The number and percentage of third grade students on track and not on track to meet year-end expectations based on assessments completed on or before March 13, 2020.
 - b. The number and percentage of third grade students retained pursuant to subsection (a) of this section for reading deficiencies.
- (3) The State Board shall compile the information described in this subsection and shall submit a State-level summary of each component by local school administrative unit and charter school to the Joint Legislative Education Oversight Committee by October 15, 2020.

For reporting purposes, the following guidance was provided to districts for reporting data:

To determine students who were not on track/on track, please consider the following:

- Students who were not on track as defined by any Alternative Assessment data
- Students who were not on track, as defined by Istation ISIP ER data. Please consider students who were Level 1 or Level 2 at the Middle of Year (MOY) benchmark or any monthly progress monitoring data up until March 13, 2020.

The following can be considered to determine not on track.

- Not on track as defined by Level 2 or below ISIP overall score
- Not on track as defined by Level 2 or below Lexile score
- Students who were on track as defined by any Alternative Assessment data
- Students who were on track, as defined by Istation ISIP ER data. Please consider students who were on track, consider students who were Level 3 or above at the Middle of Year (MOY) benchmark or any monthly progress monitoring data up until March 13, 2020. The following can be considered to determine on track.

- On track as defined by Level 3 or above ISIP overall score
- On track as defined by Level 3 or above Lexile score

NOTE: Students who lack data to determine on track or not on track status and would have otherwise been eligible for a Good Cause Exemption can be given the appropriate code in the data collection process.

Limitations

Districts were given guidance to use data from any alternative assessment used through March 13th including Istation's Indicators of Progress (ISIP) Early Reading Middle of Year (MOY) data. Data were prepopulated in the data set for MOY ISIP ER Overall Scores, which in many cases was only one data point gathered at MOY using the new Istation ISIP ER tool. The ISIP ER subtest data for the Comprehension Subtest were not available at the state level due to a change in the statewide contract that ended the statewide data dashboard and data integration. Therefore, districts were required to use data available at the district and school level to complete the reporting process, resulting in some potential reporting errors. Districts were given a data verification period of one

week following the deadline for reporting data. In comparison to historical data, districts and charters reported higher than expected number and percentage of students reported as on track to meet year end expectations on assessments completed by 3/13/2020 and students who were coded G for lack of data to determine on track or not on track status. Additionally, there are lower percentages of students reported as not on track to meet year-end expectations on assessments completed by 3/13/2020 and students retained for reading deficiencies in third grade.

Upon initial review of the RtA Annual Reports that were submitted by districts and charters, it was determined that it was necessary for additional guidance to be provided with an open data correction window to review and resubmit data. The reporting of RtA annual data for the 2019 – 2020 school year was unprecedented and provided unique reporting challenges; therefore, districts and charters were given clarifying guidance and support to review data with an open window for resubmission of RtA Annual reports. The data presented in the following tables represents reporting following the open window for data correction.
