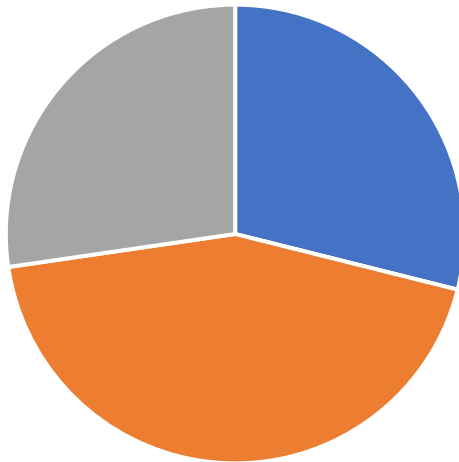

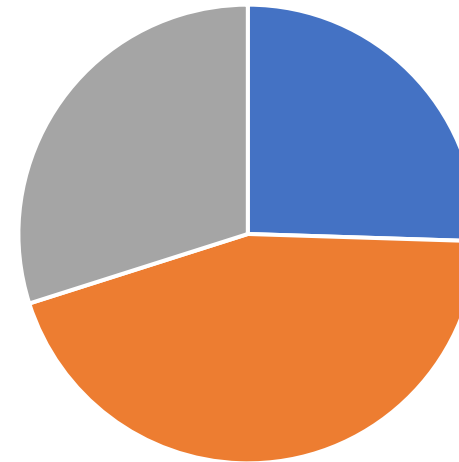

- Two schools were removed from Comprehensive Support and Improvement identification.
- One school was added to TSI-Additional Targeted Support and Improvement identification.
- One school was removed from TSI-Consistently Underperforming School identification.
- One school was removed from Low-Performing School and Continually Low-Performing School identification.
- One school had a School Performance Grade change.
- Six schools had Subgroup Letter Grade changes.
- Two schools had Reading Grades 3–8 and Mathematic Grades 3–8 long term goal target status changes.
- Six schools had Cohort Graduation Rate long-term goal target status changes.
- Four schools had participation rate status changes.
