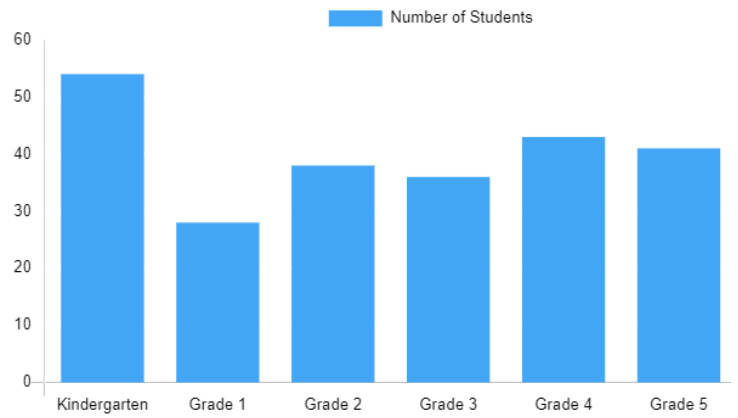

Opportunities for Parental Involvement (School Year 2022–23)

Lincoln has an active parent community, the “Parent Faculty Organization” (PFO), a non-profit organization supporting student activities. The PFO organizes fundraising events to provide student enrichment activities such as special assemblies and prizes for the weekly “Lincoln Leopards Student Store”. Parents also serve on the English Learner Advisory Committee (ELAC) and the School Site Council (SSC). These committees give advice on how to use school resources to provide the best education for our students. Parents provide input in goal setting for the “School Plan for Student Achievement”.

All parents attend annual events including Back to School Night, Parent Conferences, Winter and Spring Music Concerts, Family Math Night and monthly awards assemblies. Parents are regular volunteers in classrooms and participate on field trip excursions. Various community organizations, such as Schools of Hope and the Salvation Army, send volunteers to read with children or help them complete assignments. Types of Services Funded (Fiscal Year 2021–22)

In 2014-15 two new positions were funded with LCAP money, the Student Engagement Worker and Family Engagement Facilitator. The Student Engagement Worker runs after school clubs, organized recess activities and participates in planning monthly events for students. The Family Engagement Facilitator assists families with translation, paperwork and attends parent meetings such as PFO, ELAC, SSC and SSTs. A full-time counselor works with a part-time clinician to provide counseling services for students and families. Additional services provided by the district include a speech and language teacher who is on site 5 days a week, a school psychologist on site 1 day per week, a nurse on site 1 day per week, and a hearing and vision specialist who is available as needed.

Special Education Program

A resource specialist works with special education students who have Individualized Education Programs (IEP'S) and are in regular classrooms. We have five Special Day Classes (SDC) for educationally and emotionally challenged students ranging from mild to severe disabilities. Each of these classes has a full-time instructional assistant. Identified students also receive adaptive physical education. Teachers receive assistance and direction from an occupational therapist. If a child requires them, teachers may also receive county services such as vision and hearing screenings. Individual assistants are provided for our full inclusion students.

English Learner Program

Most students, not yet fluent in English, receive ELD instruction according to their English Language Proficiency Assessments For California (ELPAC) levels in addition to ELD instruction for the whole classroom. Primary students receive extra support with the Early Reading Intervention (ERI) curriculum. Lincoln's Intervention Team provides small group instruction during the ELD block.

Intervention Support at Lincoln School has one and a half full time Teachers on Special Assignment (TOSAs). Additionally, after-school tutoring is offered for low-performing students.

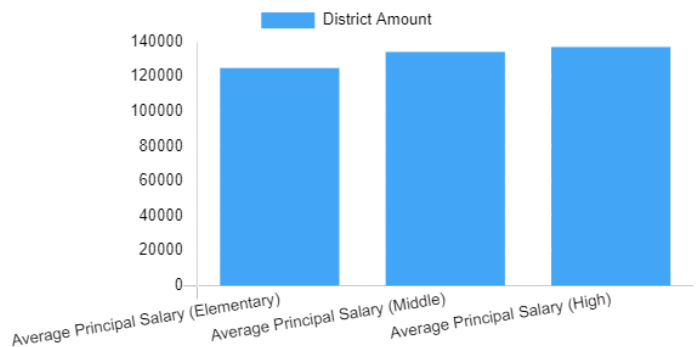
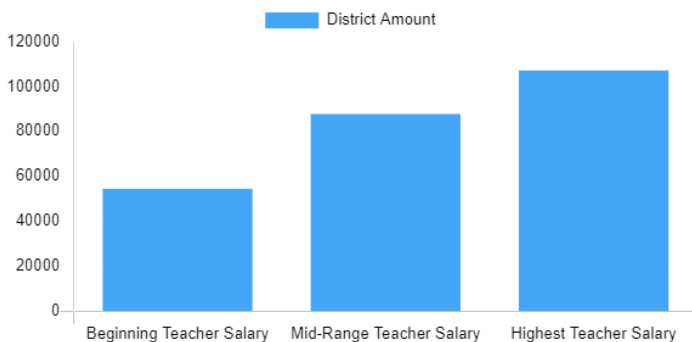
