RESOLUTION REQUESTING AND PETITIONING THE BOARD OF COMMISSIONERS FOR THE COUNTY OF WAKE, NORTH CAROLINA TO PROVIDE NECESSARY FUNDS FOR THE PURPOSE OF PAYING THE COST OF SCHOOL FACILITIES

Section 1. The Wake County Board of Education (the “Board”) hereby finds and determines as follows:

(a) It is necessary, in order to maintain adequate facilities for the proper operation and management of the Wake County Public Schools System, to acquire, construct, renovate, expand and improve additional public-school facilities in the County of Wake, North Carolina with funds expected to be appropriated by the County to the Wake County Public Schools System during the fiscal years ending June 30, 2028, and 2029.

(b) The estimated aggregate cost of such additional facilities to be financed from funds appropriated by the County to the Wake County Public Schools System during the fiscal years

ending June 30, 2028, and 2029 is approximately \$832,330,990.

(c) It is necessary to request the Board of Commissioners for the County of Wake, North Carolina to provide the necessary funds to pay the costs of the Project.

Section 2. The Board hereby requests and petitions the Board of Commissioners for the County of Wake, North Carolina to take all necessary steps, by the issuance of general obligation bonds of the County or otherwise, to provide funds for paying the costs of the Project described in Section 1 above. This includes a request that the County conduct a general obligation bond referendum in 2026 to authorize the issuance by the County of general obligation bonds in the amount of \$680,000,000.

Section 3. This resolution shall take effect upon its adoption.
