

NOTICE OF PUBLIC HEARING ON A CONVEYANCE OF REAL PROPERTY  
Notice is hereby given that the Board of Directors of the Iowa City Community School District will hold a public hearing on the 27th day of January, 2026 at 6:00 p.m. in the Educational Services Center located at 2255 N. Dubuque Road, Iowa City, Iowa 52245 on the conveyance of an easement interest in real property, pursuant to Iowa Code Sections 279.8 and 297.22. The conveyance includes a public utility easement on real estate locally known as Van Allen Elementary School, 170 Abigail Avenue, North Liberty, Iowa, 52317 (the "Property"). At the time and place set for the public hearing, interested individuals will be given the opportunity to express their views, both orally and in writing, on the following:  
Proposal to convey an easement interest in the above-described Property to MidAmerican Energy Company, Linn County Rural Electric Cooperative, Lumen, Mediacom, South Slope Cooperative, Metronet and ImOn Communications for good and valuable consideration.  
The proposal may be subject to conditions as may be stated either in the proposal, the Resolution of the Board of Directors of the Iowa City Community School District, or documents entered into between the parties.  
A copy of the proposal may be reviewed at the District administrative offices located at 1725 North Dodge Street, Iowa City, Iowa 52245.  
After the public hearing, the Board may make a final determination to accept or reject the proposal as submitted, or upon condition that certain terms be changed, or the Board may defer action on the proposals until a subsequent meeting.
