The challenge facing Sonoma County schools today is meeting the on-going educational needs of a community which has seen multiple traumatic events in recent years. Our students and staff continue to require resources to address losses from distance learning, adapt to teaching in the post-COVID era, and provide emotional support in addressing the accumulating trauma from years of fire, smoke, flood, and pandemic. Boards are challenged with addressing these issues along with other competing critical needs, including special education and funding pensions, in an environment of limited or declining funding. CSBA is well positioned to advocate with state and federal decision makers on behalf of school boards.
