**RESOLUTION OF THE BOARD OF TRUSTEES OF THE SANTA ROSA SCHOOL DISTRICT REGARDING  
REDUCTION OR DISCONTINUANCE OF CERTAIN PARTICULAR KINDS OF SERVICES (PKS) FOR THE  
2024-25 SCHOOL YEAR**

**WHEREAS**, the Board hereby finds that it is in the best interest of the SANTA ROSA CITY SCHOOLS that, as of the end of the 2023-24 school year, certain particular kinds of services now being provided by the District be reduced or discontinued as follows:

**Elementary Certificated**

1. Eliminate the equivalent of 12.6 FTE District TOSA's.
2. Eliminate the equivalent of 0.5 Site TOSA.
3. Eliminate the equivalent of 19.0 FTE Classroom Teacher.

**Secondary Certificated**

4. Eliminate the equivalent of 4.4 FTE District TOSA's.
5. Eliminate the equivalent of 0.2 FTE Site Data TOSA
6. Eliminate the equivalent of 0.2 FTE Site EL Coordinator
7. Eliminate the Equivalent of 0.2 FTE Art Quest Coordinator
8. Eliminate the equivalent of 3.4 FTE Middle School English Language Arts
9. Eliminate the equivalent of 1.4 FTE Middle School Math
10. Eliminate the equivalent of 2.4 FTE Middle School Science
11. Eliminate the equivalent of 1.0 FTE Middle School Social Science
12. Eliminate the equivalent of 1.8 FTE Middle School Physical Education
13. Eliminate the equivalent of 1.0 FTE Middle School Computer Science
14. Eliminate the equivalent of 3.4 FTE High School English Language Arts
15. Eliminate the equivalent of 1.4 FTE High School Math 1
16. Eliminate the equivalent of 1.4 FTE High School Math 2
17. Eliminate the equivalent of 2.8 FTE Higher Level High School Math
18. Eliminate the equivalent of 7.4 FTE High School Social Science
19. Eliminate the equivalent of 1.4 FTE Geosciences
20. Eliminate the equivalent of 2.0 FTE Life/Biological Sciences
21. Eliminate the equivalent of 0.4 FTE Chemistry
22. Eliminate the equivalent of 0.2 FTE Physics
23. Eliminate the equivalent of 1.0 FTE Spanish
24. Eliminate the equivalent of 0.6 FTE French
25. Eliminate the equivalent of 0.40 Career Technical Education
26. Eliminate the equivalent of 1.6 FTE High School Physical Education
27. Eliminate the equivalent of 0.2 FTE AP Computer Science
28. Eliminate the equivalent of 0.4 FTE High School Band

**Other Certificated**

- 29. Eliminate the equivalent of 6.0 FTE EL Specialist
- 30. Eliminate the equivalent of 2.0 FTE LCAP Counselor

**Secondary Administrative**

- 31. Eliminate the equivalent of 1.0 FTE.  
–Santa Rosa High School Assistant Principal

**Other Administrative**

- 32. Eliminate the equivalent of 3.0 FTE District Administrative.  
–Coordinator, Extracurricular Interventions  
–Administrator on Special Assignment, Special Services  
–Administrator on Special Assignment, Wellness and Engagement

**WHEREAS**, in the opinion of the Governing Board of this District it is necessary by reason of the aforementioned reduction and/or discontinuance of services to decrease the number of certificated employees by the equivalent of eighty four and seven hundredths (84.70) full-time equivalent employees for the 2024-25 school year;

**NOW, THEREFORE, BE IT RESOLVED** by the Governing Board of SANTA ROSA CITY SCHOOLS that, as of the end of the 2023-24 school year the foregoing particular kinds of services now being provided by said District be and hereby are reduced or discontinued to the extent hereinabove set forth.

**BE IT FURTHER RESOLVED** that the District Superintendent or Superintendent’s designee, be and hereby is authorized and directed to initiate and pursue procedures necessary not to reemploy the equivalent of eighty four and seven hundredths (84.70) full-time equivalent certificated employees of this District pursuant to Education Code sections 44949 and 44955 because of said reduction and discontinuance of services.
