**RESOLUTION OF THE BOARD OF TRUSTEES OF THE SANTA ROSA SCHOOL DISTRICT REGARDING
REDUCTION OR DISCONTINUANCE OF CERTAIN PARTICULAR KINDS OF SERVICES (PKS) FOR THE
2024-25 SCHOOL YEAR**

WHEREAS, the Board hereby finds that it is in the best interest of the SANTA ROSA CITY SCHOOLS that, as of the end of the 2023-24 school year, certain particular kinds of services now being provided by the District be reduced or discontinued as follows:

Elementary Certificated

1. Eliminate the equivalent of 0.20 FTE elementary Reading Specialist (site funded)

Secondary Certificated

2. Eliminate the equivalent of 0.20 MTSS Counselor at Montgomery High School (site funded)
3. Eliminate the equivalent of 0.35 FTE Secondary Counselor (site funded)
4. Eliminate the equivalent of 0.20 FTE Secondary TOSA (site funded)

Other Certificated

5. Eliminate the equivalent of 2.0 LCAP Counselor
6. Eliminate the equivalent of 1.0 District Library Media Specialist

Other Administrative

7. Eliminate the equivalent of 2.3 FTE District Administrative
 - Coordinator, Alternative Education (1.0 FTE)
 - Program Manager, Special Education (1.0 FTE)
 - Program Manager, Special Education (0.20 FTE)
 - Program Specialist, Special Education (0.10 FTE)

WHEREAS, in the opinion of the Governing Board of this District it is necessary by reason of the aforementioned reduction and/or discontinuance of services to decrease the number of certificated employees by the equivalent of six and twenty five hundredths (6.25) full-time equivalent employees for the 2024-25 school year;

NOW, THEREFORE, BE IT RESOLVED by the Governing Board of SANTA ROSA CITY SCHOOLS that, as of the end of the 2023-24 school year the foregoing particular kinds of services now being provided by said District be and hereby are reduced or discontinued to the extent hereinabove set forth.

BE IT FURTHER RESOLVED that the District Superintendent or Superintendent's designee, be and hereby is authorized and directed to initiate and pursue procedures necessary not to reemploy the equivalent of six and twenty five hundredths (6.25) full-time equivalent certificated employees of this District pursuant to Education Code sections 44949 and 44955 because of said reduction and discontinuance of services.
