CONSENT AGENDA

By motion of Mr. Mike Long and a second by Mr. Kevin Boyd, a unanimous affirmative vote was made to approve the Consent Agenda for the January 17, 2019, State Board meeting.

- 1. FP Contract Georgia Vocational Rehabilitation Agency (GVRA) Pre-Employment
 Transition Services. The State Board of Education authorized the State School
 Superintendent to enter into a contract with Georgia Vocational Rehabilitation Agency (GVRA) at a cost not to exceed \$70,000 in Federal Funds for Pre-Employment Transition Services (Pre-ETS).
- 2. FP Grant FY19 IDEA Funding for Students with Disabilities Attending New Charter and Expanding Charter Schools. The State Board of Education authorized the State School Superintendent to award a grant to selected LEA charters at a cost not to exceed \$26,496 in Federal Funds for the purpose of allocating previously unallocated IDEA 611 and IDEA 619 grants to include new and expanding charter school allocations in accordance with the Individuals with Disabilities Act. (Appendix 7)
- 3. SI Grant -FY19, Title I, Part A, 1003 School Improvement Grants. The State Board of Education authorized the State School Superintendent to award a grant to local educational agencies (LEAs) with schools identified as Targeted Support and Improvement and Comprehensive Support and Improvement schools at a cost not to exceed \$16,640,000 in Federal Funds for school improvement services. (Appendix 8)
- 4. <u>SI Grant Amendment Title I, Part A, Section 1003(a) School Improvement Grants RESA</u>. The State Board of Education authorized the State School Superintendent to amend the grant for Regional Education Service Agencies (RESA) by the amount of \$240,000 for a cost not to exceed \$14,048,547 in Federal Funds for the purpose of additional school improvement services. (Appendix 9)
- 5. TL Grant SREB. The State Board of Education authorized the State School Superintendent to accept a grant in the amount of \$184,600 from the Southern Regional Education Board to improve the quality and use of the Georgia resource system by conducting a collaborative, inclusive review of current resources and problems of use, and recommending new and revised resources that support more consistent use in improving teaching and learning. (Appendix 10)
- **6.** EAP Charter System Evans County Schools. The State Board of Education granted a system charter for Evans County Schools System, a grades K-12 charter system for a five-year term beginning July 1, 2019 and ending June 30, 2024.
- 7. <u>EAP SWSS Termination Evans County Schools.</u> The State Board of Education terminated the Strategic Waiver School System contract for the Evans County School System and convert their contract to a charter system contract.
- 8. <u>EAP Charter System Renewal Glascock County Schools</u>. The State Board of Education renewed a system charter for Glascock County Schools for a five-year term beginning July 1, 2019 and ending June 30, 2024.
- 9. EAP Charter Renewal Houston County College and Career Academy. The State Board of Education renewed a charter for the Houston County College and Career Academy, a grades 9-12 start-up college and career academy approved by the Houston County Board of Education, for a five-year term beginning July 1, 2019 and ending on June 30, 2024.

- 10. <u>EAP Charter Renewal New Life Academy of Excellence.</u> The State Board of Education renewed a charter for New Life Academy of Excellence, a grades K-8 start-up charter school approved by the Gwinnett County Board of Education, for a 5-year term beginning July 1, 2019 and expiring June 30, 2024.
- 11. <u>EAP Charter Amendment Catoosa County Schools.</u> The State Board of Education approved a charter system contract amendment for Catoosa County Schools to increase the charter term by one year to expire June 30, 2022, in order to align with the district's SACS accreditation process.
- 12. <u>EAP Start-Up Charter 7 Pillars Career Academy.</u> The State Board of Education approved to grant a charter to 7 Pillars Career Academy, a grades 6-12 start-up charter school approved by the Clayton County Board of Education, for a five-year term beginning July 1, 2019 and ending June 30, 2024.
- 13. TL Standards Automotive Technology Pathway Courses (Adoption). The State Board of Education adopted the Georgia Standards of Excellence for General Automotive Technology Course 1, General Automotive Technology Course 2, General Automotive Technology Course 3, Advanced Automotive Technology Course 4, Advanced Automotive Technology Course 5, Advanced Automotive Technology Course 6 which will subsequently be added to the State-Funded List of K-8 Subjects and 9-12 Courses.
- 14. TL Standards Middle School Immersion Courses (Adoption). The State Board of Education adopted the Georgia Standards of Excellence for Modern Languages 6th grade DLI Advanced Languages Literacy, Modern Languages 6th, 7th & 8th grade DLI Culture & History, Modern Languages 6th, 7th & 8th grade DLI Media Literacy, and Modern Languages Level 3 Spanish for Native Speakers which will subsequently be added to the State-Funded List of K-8 Subjects and 9-12 Courses.

- 1. The meeting was called to order by the State Board of Education (SBOE) District Flexibility and Charter Schools Committee Chair Kevin Boyd at 10:20 a.m.
 - In addition to Mr. Boyd, Committee members Scott Johnson, Lisa Kinnemore, and Van Parrott were present.
 - Associate State Superintendent for District Flexibility, Charter Schools, Policy, and Governmental Affairs Louis Erste; District Flexibility and Charter Schools (DFCS) Director Allen Mueller; and DFCS Accountability Manager Kerry Pritchard were also present.
 - State Charter Schools Commission (SCSC) Interim Director and General Counsel Gregg Stevens was present, along with Charter Advisory Committee (CAC) Chair Mark Whitlock and Governor's Office of Student Achievement (GOSA) Director of Policy, Research and Evaluation Rosaline Tio.
 - Ten school district and charter school advocates and representatives were also present along with representatives of the governing board of Seven Pillars of Mastery from Clayton County and their school leader.
 - Evans County School Superintendent Dr. Martin Waters and his team; Glascock County School Superintendent Mr. James Holton, Board of Education Chair Mr. Michael Gilmer, and the district's principals; Houston County College and Career Academy governing board chair Mr. Michael Chalmers, board members, and Principal Ms. Sabrina Phelps; and New Life Academy governing board chair Ms. Theresa Thomas, board members, and Executive Director Mr. Alphonsa Foward joined the meeting by conference call.
- 2. Mr. Boyd welcomed the Committee, staff, partners, and others in attendance. Ms. Kinnemore read the Committee's Mission Statement.
- 3. At Mr. Boyd's request, Mr. Whitlock presented the CAC's recommendation for approval of a new charter system contract for the Evans County School system for a five-year term

beginning July 1, 2019 and ending June 30, 2024. Mr. Mueller then presented the Department's recommendation for approval. Evans County Superintendent Waters spoke briefly about the initiatives his district would implement as a charter system.

- Follow-up questions were asked by the Committee and discussion ensued.
- Mr. Boyd requested, and Mr. Johnson made a motion to move this Action Item to the Consent Agenda. Ms. Kinnemore seconded the motion, which was approved 4-0.
- 4. At Mr. Boyd's request, Mr. Whitlock presented the CAC's recommendation for approval of a charter system contract renewal for the Glascock County School system for a five-year term beginning July 1, 2019 and ending June 30, 2024. Mr. Mueller then presented the Department's recommendation for approval. Glascock Superintendent Holton, BOE Chair Gilmer, and the district's principals spoke briefly about the initiatives their district would implement as a charter system.
 - Follow-up questions were asked by the Committee and discussion ensued.
 - Mr. Boyd requested, and Ms. Kinnemore made a motion to move this Action Item to the Consent Agenda. Mr. Johnson seconded the motion, which was approved 4-0.
- 5. At Mr. Boyd's request, the following updates were presented.
 - Mr. Whitlock reported that the Charter Advisory Committee (CAC) had a regular meeting on December 7, 2018 that included and update on the Title I Consolidation Plan, updates to the CCRPI and its impact on charter system accountability, the charter system renewal request of Glascock County, and reports from the GaDOE and Charter System Foundation consultant on their support for charter systems.
 - Ms. Tio reported that the Governor's Office of Student Achievement (GOSA) had sent out to all Strategic Waivers School Systems, along with new CCRPI targets based on the new CCRPI for 2018, revised Exhibits C, D, and E-F-G for districts to submit if they wished to retain their flexibility. She reported that GOSA had also sent out a reminder to districts that the SBOE would vote on these SWSS contract amendments at their February 2019 meeting.
 - Mr. Stevens announced that the SCSC had a leadership change, with Dr. Bonnie Holliday leaving to join the Georgia Charter Schools Association. He also discussed the upcoming SCSC meeting at which Commissioners will consider granting state charters to two locally-approved charter schools, Academy for Classical Education in Bibb County and Baconton Community Charter School in Mitchell County. The SCSC will also consider a Rule that would set guidelines for charter schools that enter contracts which exceed the length of the charter school term.

He also reported that TCSG had approved the certification required by law for the Academy. Mr. Whitlock provided a brief overview of the Academy's history of excellent performance and strong community partnerships. Ms. Phelps and her team spoke briefly about the initiatives their Academy would implement during the next five years if their charter was renewed.
 - Follow-up questions were asked by the Committee and discussion ensued.
 - Mr. Boyd requested, and Mr. Parrott made a motion to move this Action Item to the Consent Agenda. Ms. Kinnemore seconded the motion, which was approved 4-0.
- 7. At Mr. Boyd's request, Mr. Erste provided an update on the impact that the new CCRPI would have on charter school accountability for 2018. Mr. Erste also discussed the revised charter school contract accountability appendix that would be used for all new charter schools and for charter school contract renewals in the current 2018-19 petitions review cycle—and that it would be offered to all existing charter schools not up for renewal that wished to amend their charter contracts.
- 8. At Mr. Boyd's request, Mr. Mueller presented the Department's recommendation for approval of a charter school contract renewal for New Life Academy for a five-year term beginning July 1, 2019 and ending June 30, 2024. Board Chair Ms. Thomas and her team spoke briefly about the initiatives their school would implement during the next five years if their charter was renewed. They also addressed the work they had done to ensure the appropriate balance of governing board and management, given the strength of their Executive Director Mr. Alphonsa Foward and a less-engaged governing board in years past.
 - Follow-up questions were asked by the Committee and discussion ensued.
 - Mr. Boyd requested, and Mr. Johnson made a motion to move this Action Item to the Consent Agenda. Ms. Kinnemore seconded the motion, which was approved 4-0.
- 9. At Mr. Boyd's request, Mr. Mueller presented the Department's recommendation that Catoosa County School's charter system contract be amended to align the contract term with its SACS accreditation cycle. This amendment would extend the charter term by one year to expire June 30, 2021 instead of expiring on June 30, 2020.

Project Overview

Project Goal

To improve the quality and use of the Georgia resource system by conducting a collaborative, inclusive review of current resources and problems of use, and recommending new and revised resources that support more consistent use in improving teaching and learning.

Phase 1: Analysis of Resources

Timeframe: December 2018 through June 2019

During Phase 1, SREB, Georgia Department of Education (GADOE) and members of the Georgia State Board of Education will partner to create a Core Planning Team for the project. The team will include members of the Georgia State Board of Education, several SREB staff members and Dr. Eric Thomas, the Chief Turnaround Officer, and Stephanie Johnson, Deputy Superintendent for School Improvement, from GADOE. The Core Planning Team will be responsible for selecting educators from across the state to participate, developing meeting agendas, and ensuring the goals of the project are met.

Members of the Georgia State Board of Education and the Core Planning Team will invite RESA representatives and district-level representatives to be part of the project Steering Committee. The Steering Committee will be responsible for reviewing existing resources and identifying gaps, analyzing problems of use, and formulating recommendations for system improvement and new resources.
