**NOTICE OF PUBLIC HEARING OF THE
PLACER UNION HIGH SCHOOL DISTRICT
Trustee Area Boundaries**

NOTICE IS HEREBY GIVEN that the Board of Trustees (“Board”) of the Placer Union High School District (“School District”) will hold a Public Hearing at its Regular Meeting, to be held on March 19, 2024, to gather public input regarding the potential composition of trustee area boundaries.

The Placer Union High School District’s Board of Trustees is currently elected under an “at-large” election system, where Board members are elected by voters of the entire District. On January 16, 2024, the Board adopted Resolution No. 17:23-24, signaling its intent to transition to by-trustee area elections. In a by-trustee area election system, each Board member must reside within the designated trustee area boundary and is elected only by the voters in that trustee area. On February 20, 2024, the Board held the first of two public hearings to gather input on composition of potential trustee areas pursuant to Elections Code section 10010. On March 19, 2024, at 6:00 p.m., the Board will hold a second public hearing at the Lynn MacDonald Education Center (located at 3775 Richardson Drive, Auburn, California 95602) to gather input on composition of potential trustee areas pursuant to Elections Code section 10010. The public is invited to participate and make comments during the public hearing.
