Expanded Learning Opportunities Grant Plan

Overview

- The California Legislature signed COVID-19 Relief and School Reopening Grant AB 86 in March 2021, which approved \$4.6 billion for Expanded Learning Opportunities (ELO) Grants for 2020-21.
- In order for school districts to be eligible, an Expanded Learning Opportunities Grant Plan must be adopted by the local governing board at a public meeting on or before June 1, 2021, and must be submitted to the County Office of Education within five days of adoption.
- These funds may be used for any eligible expenditures from the start of the 2020–21 fiscal year on July 1, 2020, through August 31, 2022.
- This proposed Expanded Learning Opportunities Grant Plan fulfills this requirement and provides the road map for our expanded learning opportunities for our students funded by this allocation of \$2,435,065 for the Santa Rosa Elementary District and \$7,203,987 for the Santa Rosa High School District for a total of \$9,639,052 to Santa Rosa City Schools (not including Charter Schools) for expanded learning opportunities.

- Tests in place of SBAC (The Illuminate Test Bank) will be analyzed for grades, 3-8 and 11

A SUMMARY description of the LEA's plan to provide supplemental instruction and support:

- \$4,844,246 for 2020-21 Summer School (In Person Extended School Year Program Approved at the April 28, 2021, Regular Board Meeting) & 2021-22 Summer School, the extending instructional learning time component of the plan.
- \$944,806 for Paraprofessionals, the accelerating progress to close learning gaps through enhancement of learning supports component of this plan.
- \$1,400,000 for teachers to minimize combination classes and maintain class sizes, the integrated student supports to address other barriers to learning component of this plan.
- \$2,450,000 in remaining grant funds to be more clearly define with planning, but included in the plan is a budget for this towards these allowable uses with this grant:
 - Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports
 - Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility
 - Additional academic services for students
 - Training for school staff on strategies to engage students and families in addressing students' social-emotional health and academic need
