# “By-Trustee Area” Election System

- District transitioned from “at-large” to “By-Trustee Area” election system in 2017.
- School district is divided into trustee areas
- A governing board member is elected from each trustee area
- Board members are elected **by only the registered voters in the particular trustee area** where the governing board member resides



# Assessment Must Be Completed after Federal Census

- Once transition made to by-trustee area election system, then following each federal census→ Governing Board must conduct an assessment to determine if population in each trustee area is still balanced.

(Education Code section 5019.5(a).)





# Impact of 2020 Census:

- Assessment: Review of present trustee area map using population from 2020 Federal Census.
- Demographer has completed assessment and has determined the population is no longer balanced.
- Population variance between largest and smallest trustee area is  $> 10\%$



## DISTRICT DEMOGRAPHICS

### 2020 CENSUS DATA

- Validated redistricting data was finalized by the California Department of Finance on September 27, 2021.
- This data showed substantial changes in the area served by Santa Rosa City Schools from 2010 to 2020, including:
  - Overall population growth of over 2,861 (1.4%)
  - Total Variance of 22.4% based on 2020 Census (*Out of Compliance*)

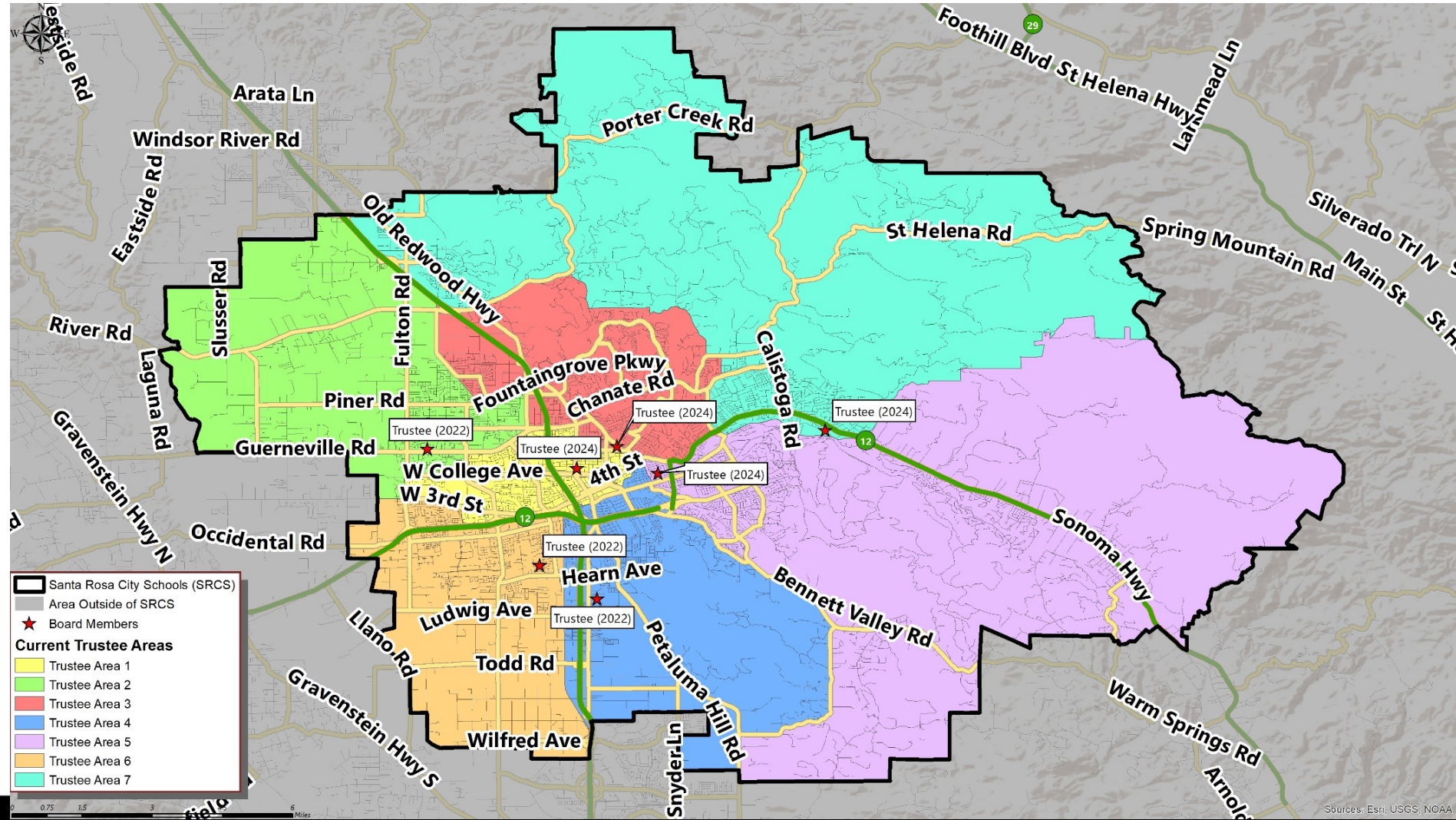


# **Impact of Census: Population No Longer Balanced**

- Board must adjust the boundaries to ensure compliance.
- Demographer is preparing draft map options that ensure compliance for the Board's review and adoption.
- Board must approve map with adjusted boundaries before March 1, 2022.
- Variance of 10% or less is permissible

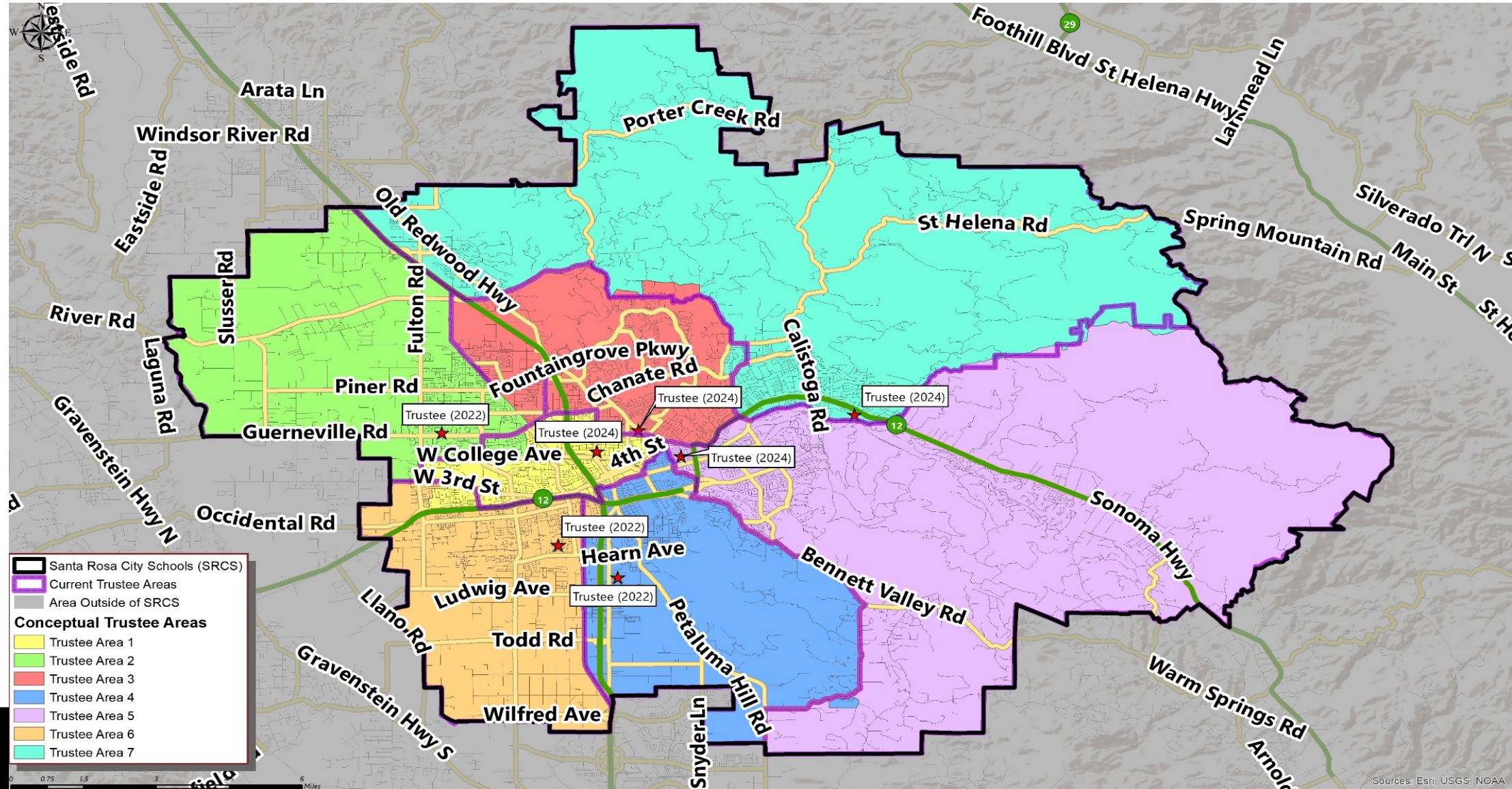

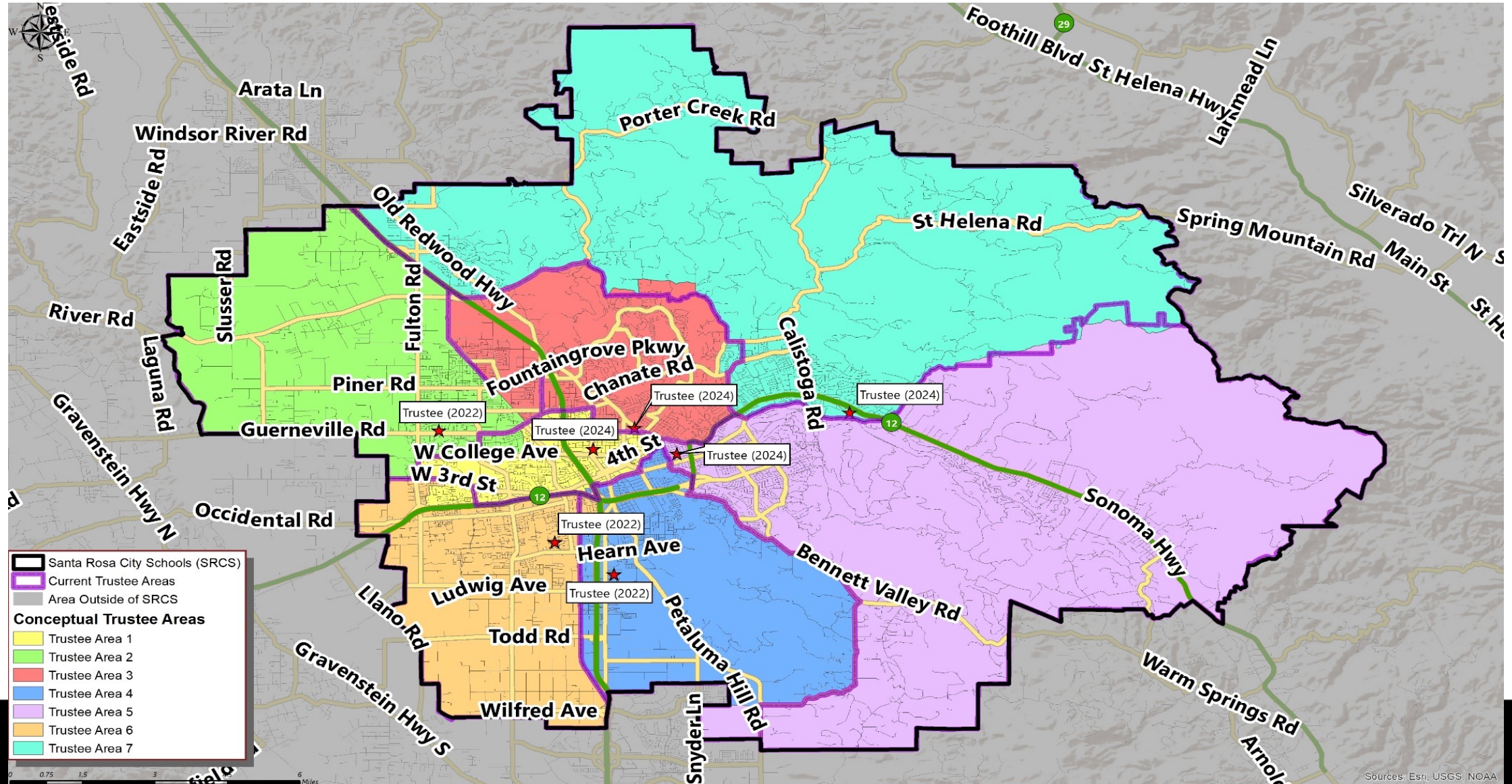

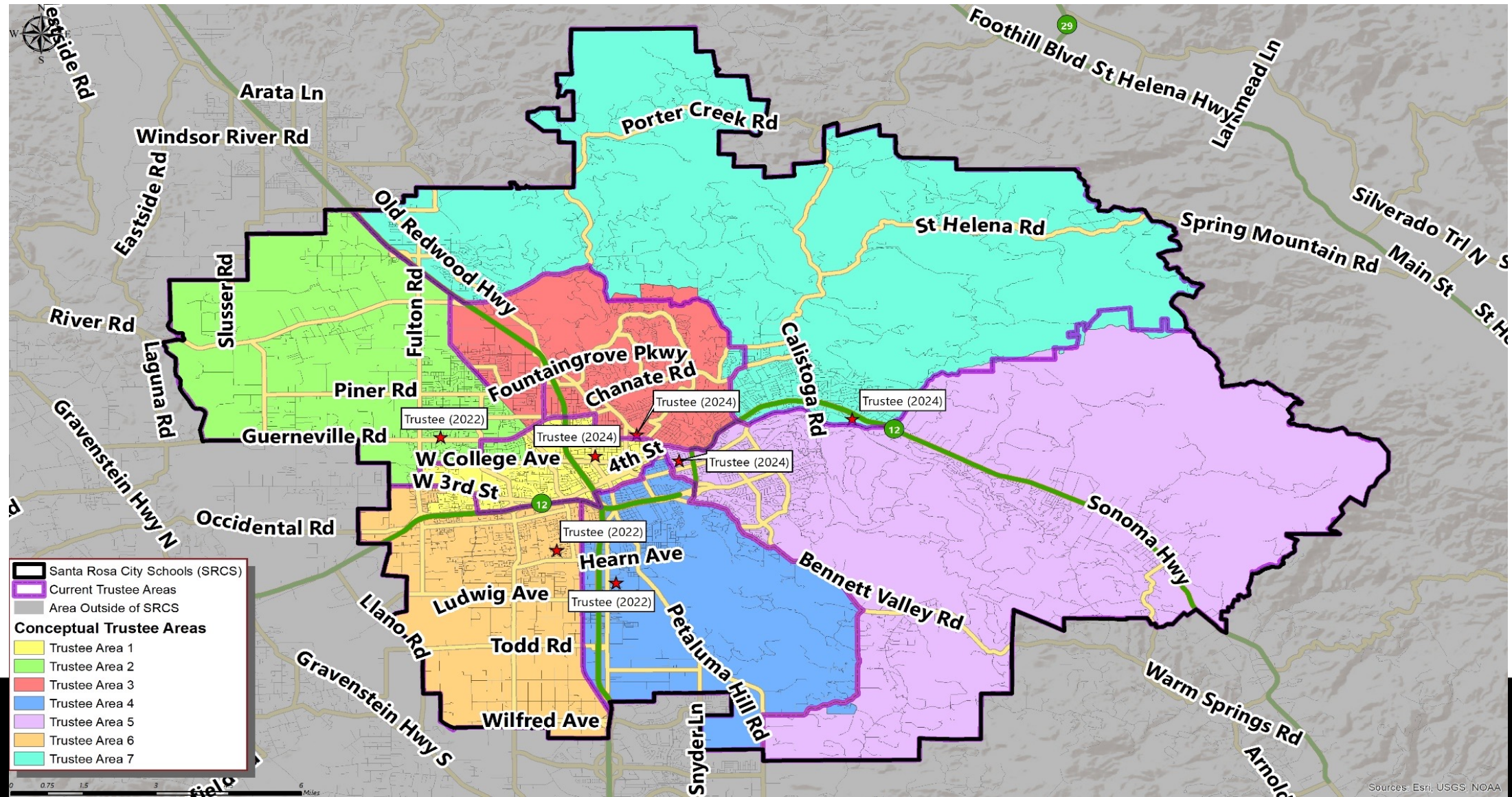

- January 26, 2022 - Presentation and public hearing regarding the adjusted map options
  - Options posted on District website
  - Public invited to public hearing
  - Demographer creates several map options with “adjusted” Trustee Area boundary lines to balance population across each area to within the permissible 10% variance
  - Presentation that trustee area map is out of compliance,
- February 9, 2022/February 23, 2022
  - Public hearing on adjusted map options
  - Board selects adjusted map option
