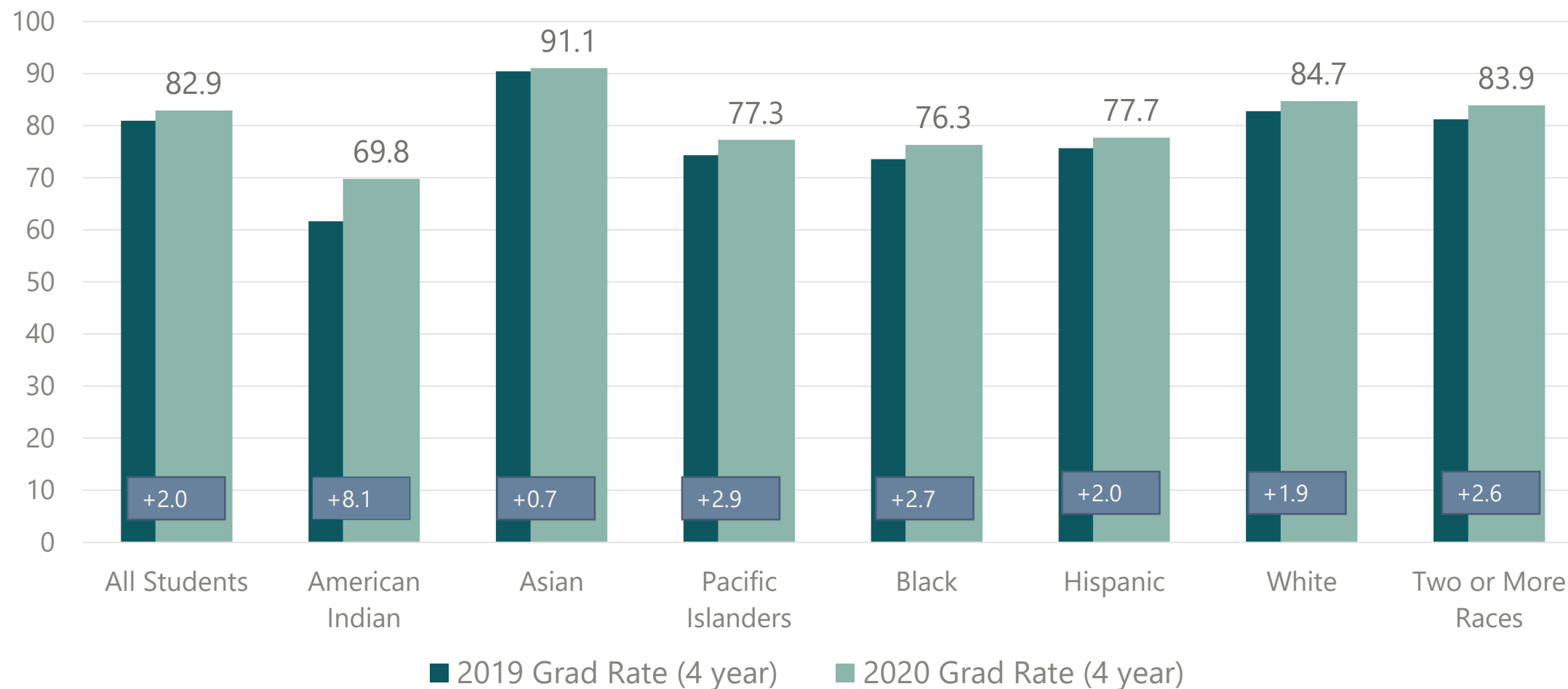

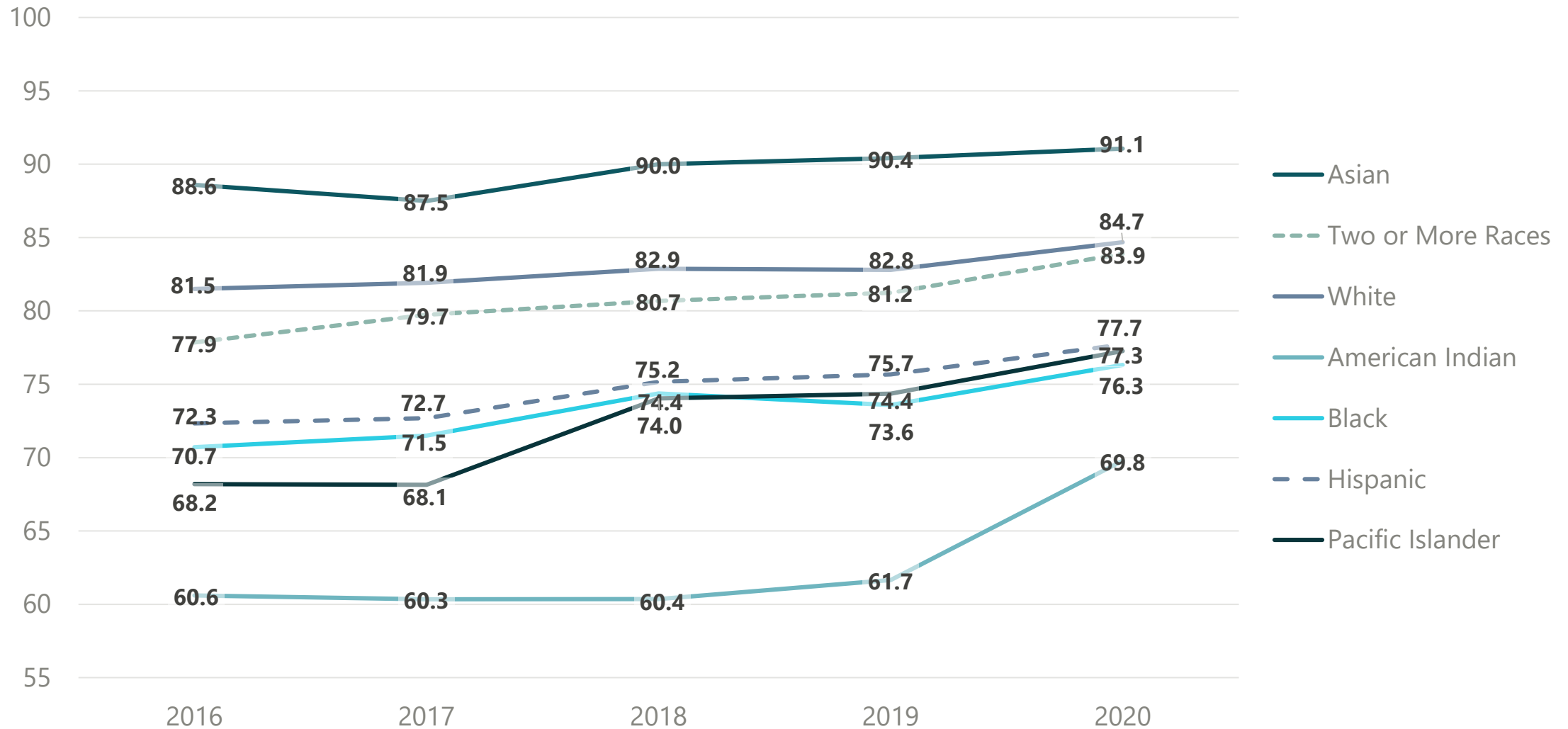

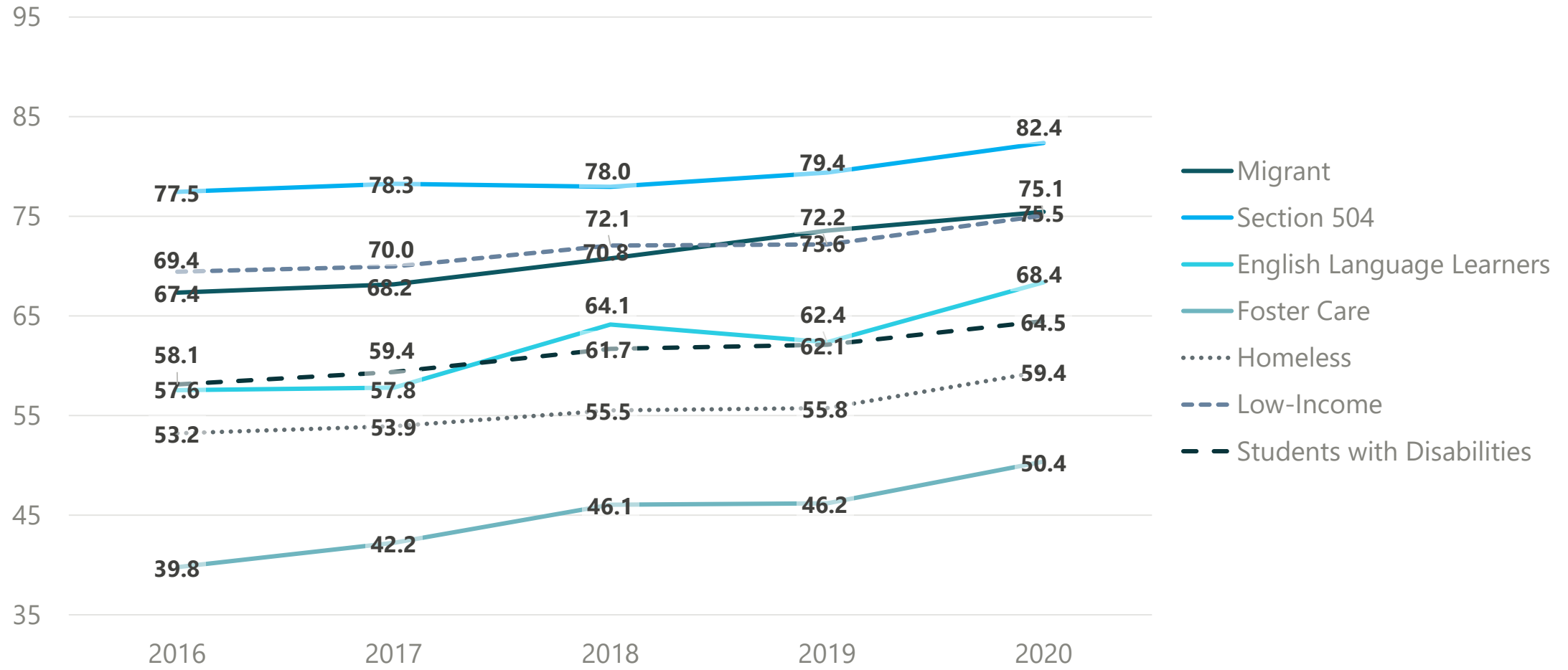
Grad Rate (4-year cohort): 2019 to 2020



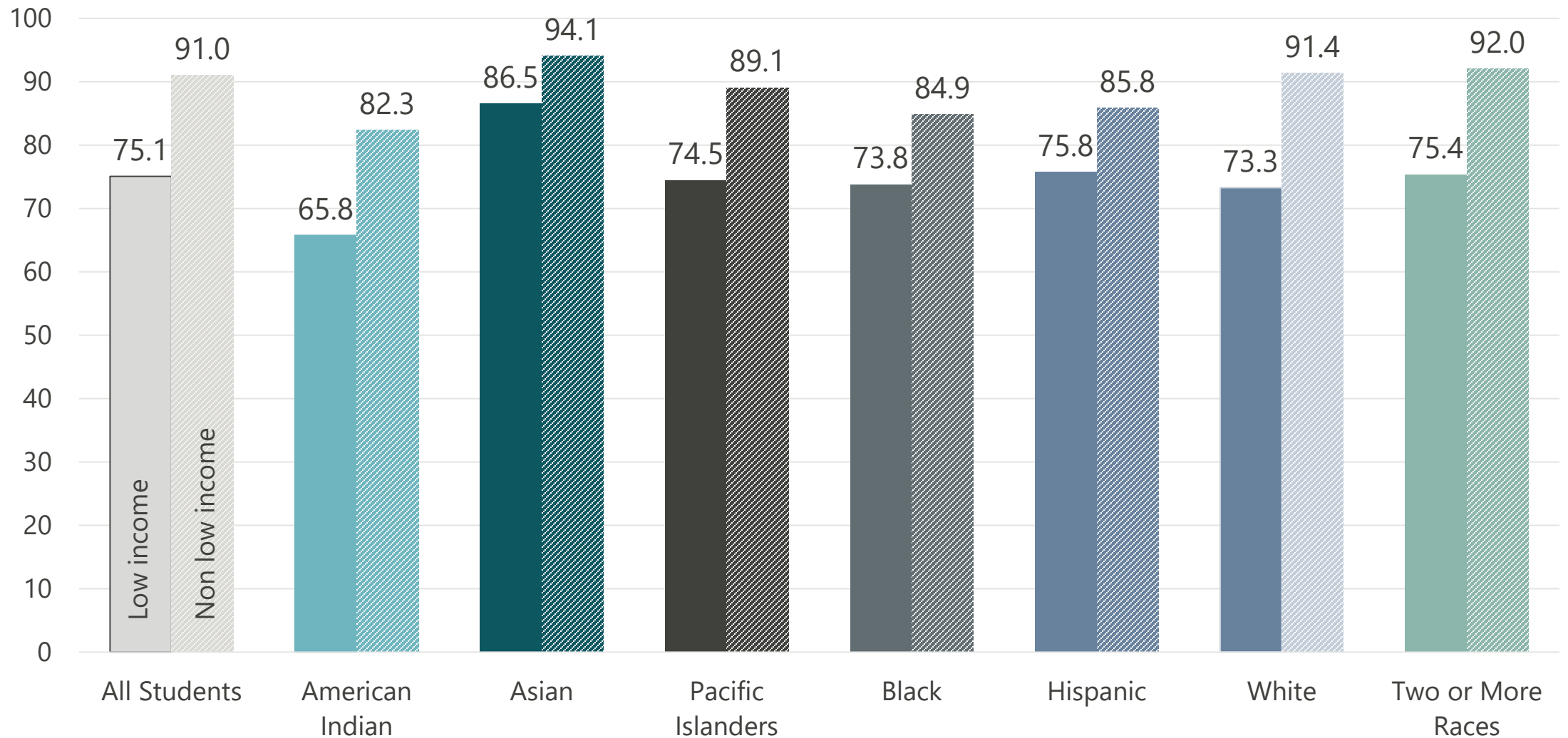
Grad rate over time by race/ethnicity

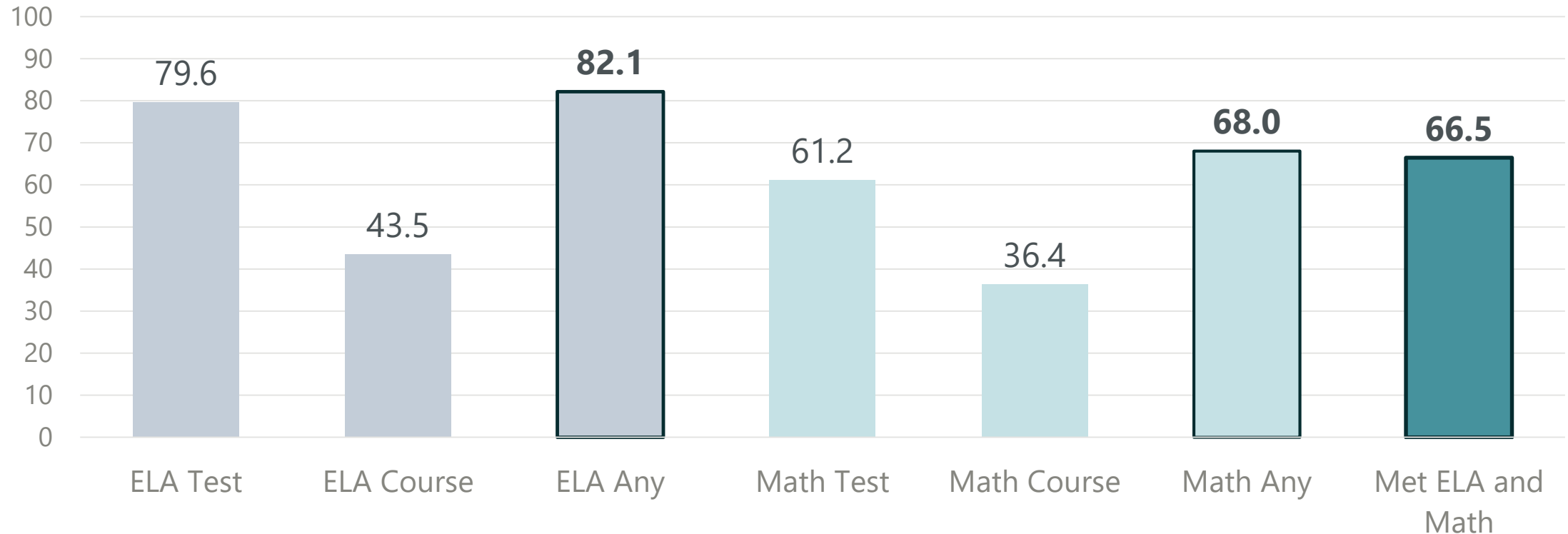

Pathways Components Completed for ELA/Math Pathway

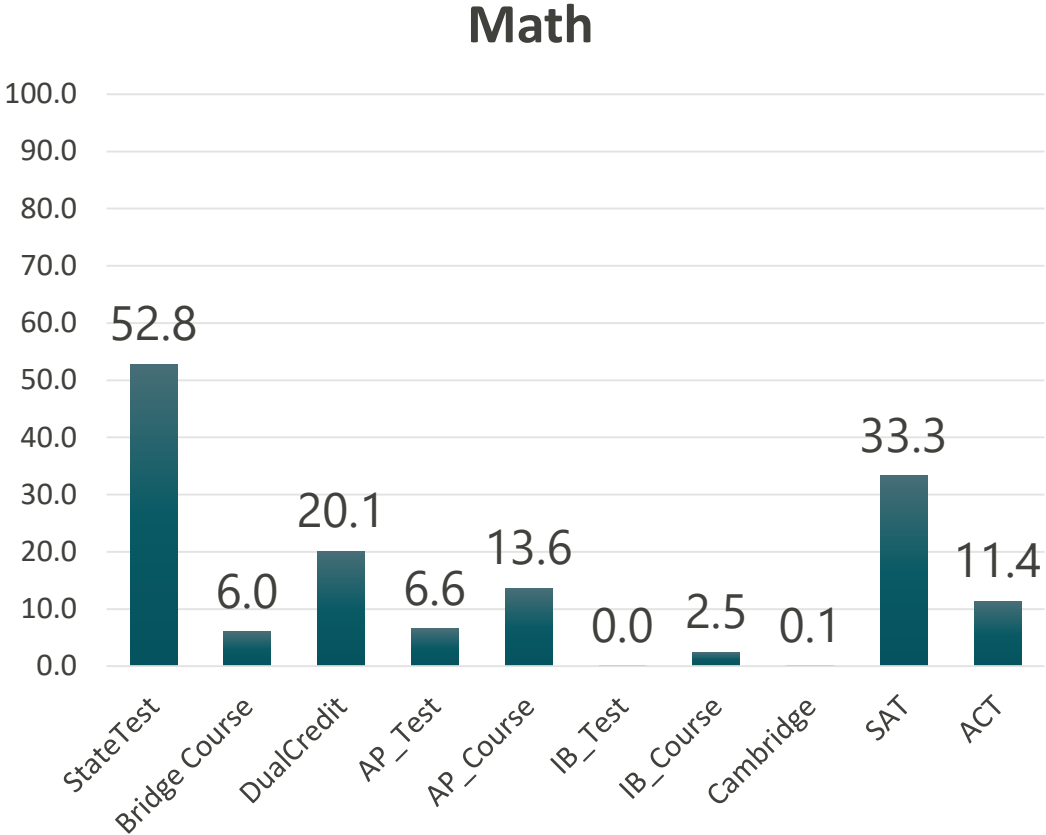
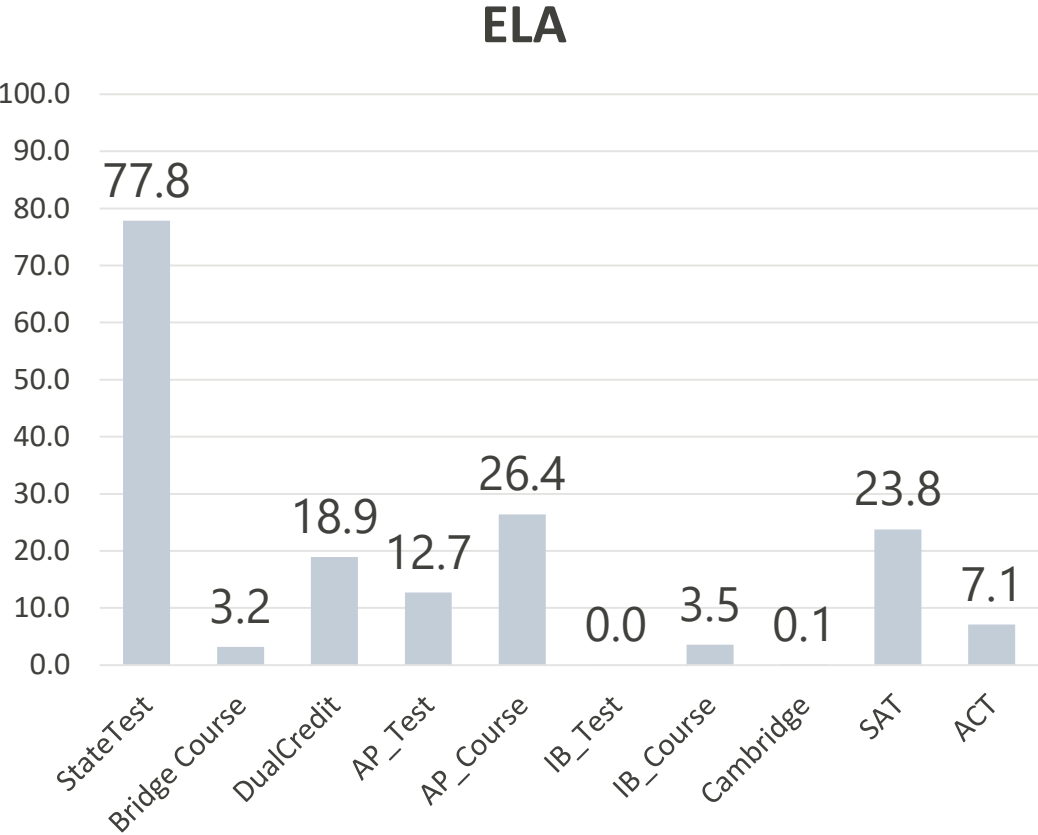


These data show how students met the ELA/Math pathway. For example, 79.6 percent of students completed *at least one* ELA test (Smarter Balanced or SAT or AP, etc.). Similarly, 82.1% of students completed the ELA component of the ELA/Math pathway, by either a test or a course.

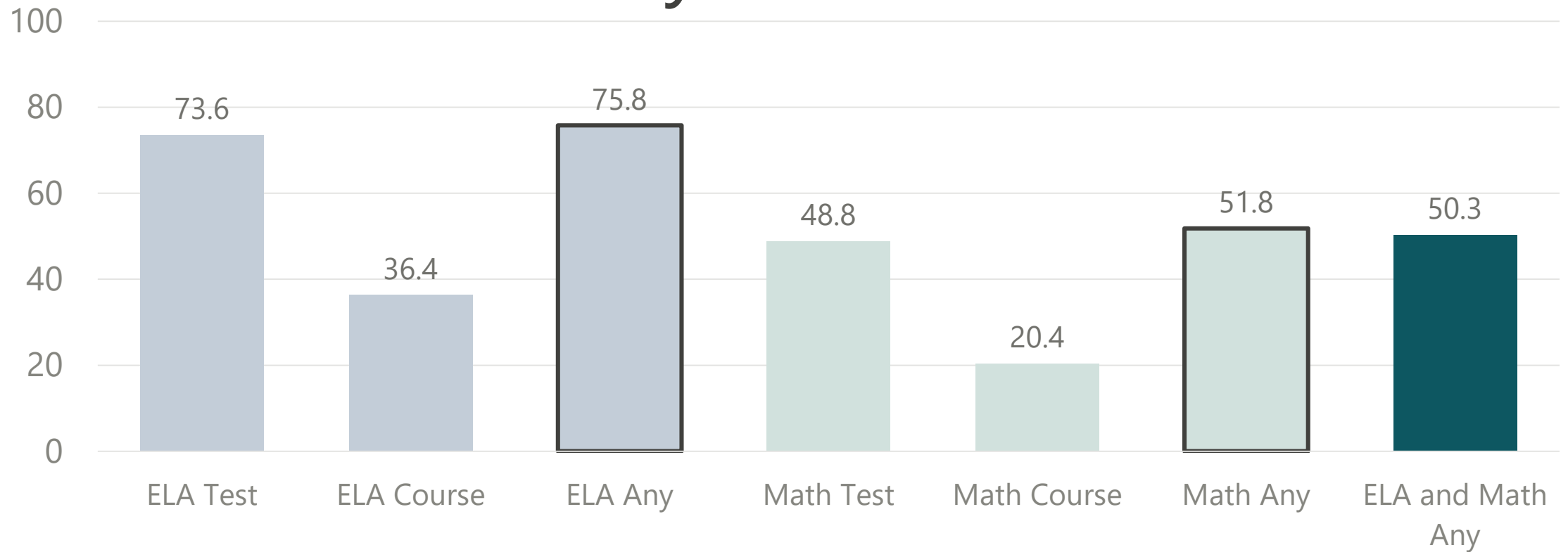

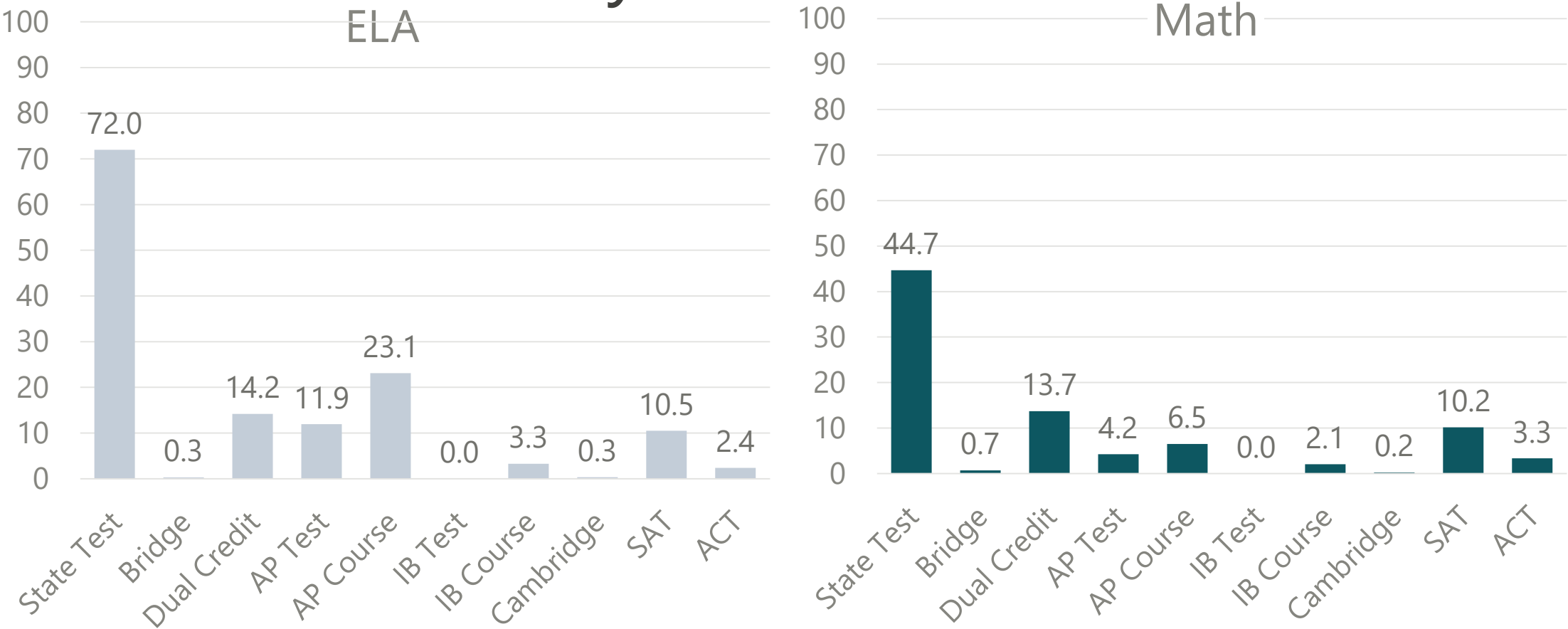
